Instructions for Contributors

The Journal of Navigation is an international journal publishing original work on the latest research developments and historical aspects of navigation on land, at sea and in the air; it also provides a forum for navigators, engineers and academics to raise more controversial topics for discussion.

SUBMISSIONS

The Editor encourages submissions to the *Journal* by an e-mail attachment, or on a CD, preferably using MS Word. Copies of illustrations/figures should be in colour and need to be to a high standard or provided as hard copy prints. If submission is by post as a hard copy manuscript then two copies (the original plus one), should be submitted to the Editor:

Articles intended for consideration in the main section should be 4000–6000 words long. However the FORUM section exists for the expression of opinion, and allows authors to submit material which might not be appropriate for full length articles but which contains ideas worthy of publication and discussion (1500–2500 words). Authors are responsible for ensuring that all manuscripts (whether original or revised) are accurately typed before final submission. Manuscripts may be returned to the author with a set of instructions if they are submitted in a form substantially different to our style.

Contributions are normally received with the understanding that they comprise original, unpublished material and are not being submitted for publication elsewhere. Translated material, which has not been published in English, will also be considered. Most articles are refereed to ensure both accuracy and relevance, and amendments to the script may thus be required before final acceptance. On acceptance, contributions are subject to editorial amendment, but authors will receive proofs for approval before publication. Corrections can be returned by normal (or air) mail or fax/e-mail if these are minor amendments (see PROOFS).

PRESENTATION OF MANUSCRIPTS

Manuscripts should be typed single-sided and double-spaced, and conform as closely as possible to the *Journal* style. Every sheet should be numbered. Footnotes, abstract

and references should also be double-spaced. International Standard Size A4 paper is preferred with a left-hand margin of 40 mm.

Arrangement of papers:

- 1 Short title (up to 40 characters including spaces), subtitle (if desired), author's name, affiliation and e-mail address (if desired). Respective affiliations of co-authors should be clearly indicated.
- 2 Self-contained abstract of up to 100 words, outlining in a single paragraph the aims, scope and conclusions of the paper; key words (maximum four).
- 3 Main body of text, suitably divided either under numbered side headings with unnumbered and un-titled paragraphs, or numbered main paragraphs with titles containing related, numbered sub-paragraphs for which further headings are optional (i.e. paragraph numbering – 3., 3.1, 3.1.1 etc).
- 4 Acknowledgements (if any).
- 5 References.
- 6 Appendices if appropriate.
- 7 Originals of tables used in the text (each on a separate sheet).
- 8 Originals of illustrations used in the text (preferably with captions on a separate sheet or well separated from the illustration to enable scanning).

The text should be organised under appropriate side or main paragraph headings, which, ideally, should not be more than 500–600 words apart. If side headings are used, they should be in capitals and placed on the left-hand side at the start of the related text, with a double-line space above and below. If main paragraph headings are used, they should be in capitals and placed at the beginning of the paragraph text with a double-line space above; the first line of sub-paragraphs should be indented with titles in italics. Authors are urged to write as concisely as possible, but not at the expense of clarity. Descriptive or explanatory passages, necessary as information but which tend to break up the flow of text, should be put into appendices. Units, symbols and abbreviations should conform to the recommendations contained in the Royal Society publication *Quantities, Units and Symbols* (1975).

REFERENCES

For **The Journal of Navigation** the Harvard style system is the preferred reference system: authors' names (no initials) and dates (and specific pages, only in the case of quotations) are given in the main body of the text, e.g. (Kemp, 1998. P.29) or (Steele and White, 1996). References should be listed alphabetically at the end of the paper, double spaced and conform to current *Journal* style as below:

Other publications

Where there is doubt include all bibliographical details.

TABLES

Tables should be numbered consecutively in Arabic numerals and given a suitable caption. Notes and references within tables should be included with the tables, separately from the main text. Notes should be referred to by superscript letters. All table columns should have an explanatory heading. Tables should not repeat data available elsewhere in the article, e.g. in an illustration.

ILLUSTRATIONS

All graphs, diagrams and other drawings should be referred to as Figures, which should be numbered consecutively in Arabic numerals and good camera-ready copies provided on separate sheets at the end of the manuscript. Colour is welcomed for all Figures which should be accompanied by captions well separated from the illustration to enable scanning. Copies should also be included in the text or their required position clearly indicated. Photographs are welcomed, where they add materially to the text. Only the original need be submitted; it should be identified on a label (by number, article title and journal) on the back. Electronic figures are preferred as 'tiff' or 'eps' files at 300 dpi.

COPYRIGHT

By submitting an article for possible publication, authors are expected to agree to the 'Transfer of Copyright' should the article be selected for publication. This transfer enables Cambridge University Press (on behalf of The Royal Institute of Navigation) to protect the copyrighted material for the authors, but does not relinquish the author's proprietary rights. The transfer of copyright covers the exclusive rights to reproduce and distribute the article, including reprints, photographic reproductions, microform or any other reproduction of similar nature and translations, and includes the right to adapt the article for use in conjunction with computer systems and programs, including reproduction or publication in machine-readable form and incorporation in retrieval systems.

CHECKLIST

- Have you told readers, at the outset, what they might gain by reading your paper?
- Have you made the aim of your work clear?

- Have you explained the significance of your contribution?
- Have you set your work in the appropriate context by giving sufficient background (including relevant references) to your work?
- Have you addressed the question of practicality and usefulness?
- Have you identified future developments that may result from your work?
- Have you structured your paper in a clear and logical fashion?

PROOFS

One set of proofs will be sent by e-mail to the corresponding author before publication, which should be returned *promptly* to the Editor by e-mail if the proposed amendments are minor or by first-class mail (by Express Air Mail if outside the UK). The publishers reserve the right to charge for any amendments made at the proof stage (other than printers' errors) since the insertion or deletion of a single word may necessitate the resetting of whole paragraphs.

OFFPRINTS

A pdf file of the final printed paper will be sent free of charge by e-mail to the corresponding author for their use.

THE ROYAL INSTITUTE OF NAVIGATION

Aims and Objects

The objects of the Institute are to unite in one body those who are concerned with or who are interested in navigation and to further its development. Navigation is conceived as applying to locomotion of all kinds and is perceived as encompassing aspects of: command and control, psychology and zoology, operational research, risk analysis, theoretical physics, operation in hostile environments, instrumentation, ergonomics, financial planning and law as well as electronics, astronomy, mathematics, cartography and other subjects traditionally associated with navigation.

The aims of the Institute are to encourage the creation and dissemination of knowledge through research and development, to co-ordinate information from all the disciplines involved, to provide a forum in which new ideas and new products can have the benefit of informed and professional scrutiny and to further education and communication.

The Institute initiates conferences and symposia on specific subjects and has a programme of meetings at which lectures are given and discussed. There are standing Special Interest Groups (SIGs) which keep under constant review pertinent aspects of navigation. The success of these Special Interest Groups is crucially dependent on the active involvement of members.

The SIGS include: Animal Navigation Group (ANG), Civil and Military Aviation Group (CMAG), General Aviation Navigation Group (GANG), History of Air Navigation Group (HANG), Land Vehicle Navigation Group (LVNG), Marine Traffic Navigation Group (MTNG), Navigation On Foot (NOF), Small Craft Group (SCG) and Satellite Special Interest Group (SATSIG).

The Institute publishes *The Journal of Navigation* four times a year. It contains papers which have been presented at meetings, other original papers and selected papers and reports from Special Interest Groups. The Institute also publishes *Navigation News* six times a year which contains a full account of the Institute's proceedings and activities. This includes Branch News, a record of current navigational work, a diary of events, topical articles, news about Membership and advertising. A great deal of the Institute's work is international in character and is co-ordinated with that of similar organizations in other countries.

Membership

There are seven classes of Membership of the Institute:

(1) HONORARY FELLOWS: Distinguished persons upon whom the Council may see fit to confer an honorary distinction.

(2) FELLOWS: Members, of at least three years' standing, holding certain qualifications laid down in the by-laws; these qualifications include having made a contribution of value to navigation.

(3) ASSOCIATE FELLOWS: Individuals who satisfy the Council of their high level of professional achievement or experience in the advancement of navigation operations, concepts or equipment.

(4) MEMBERS: Persons over twenty-one years of age who satisfy the Council of their interest in navigation.

(5) STUDENT MEMBERS: Persons under twenty-five years of age studying at a recognized school or university with a view to making navigation, or an allied interest, their career.

(6) CORPORATE MEMBERS: Organizations such as universities, navigation schools, government departments or companies, here and abroad, who are directly or indirectly interested in the science of navigation. Corporate Members are entitled to send representatives to all Institute meetings and to receive six copies of its publications. They are encouraged to take an active part in the Institute's work. Applications should be sent by letter addressed to the Director.

(7) RETIRED MEMBERS: Fellows or Members of 65 years of age or over who have paid no fewer than 6 annual subscriptions.

There is also Associateship of the Institute, which gives entitlement of Membership to one Special Interest Group SIG, but not to receipt of the *Journal of Navigation*.
