**Thomas H. C. Lee** explores here the civil service examinations begun in China during the Sung dynasty. He focuses on the social and economic developments which allowed such a system—based on merit instead of birth—to flourish, creating a unique meritocracy within an authoritarian state. Using documents from the period, Lee analyzes exactly who the degree holders were and what relation the influential families had to the civil service. This fascinating study of a little-known period reveals some surprisingly modernistic structures that existed in the distant past.
