The Contributors

SEAN ATKINSON is an assistant professor of Music Theory at Texas Christian University, where he teaches classes in music theory, aural skills, multimedia studies and meaning in music. He earned his Masters and PhD degrees in music theory from Florida State University. Sean's research, which focuses on issues of meaning in music within a multimedia context, can be found in *Music Theory Online*, *Indiana Theory Review*, *The Dutch Journal of Music Theory* and *College Music Symposium*.

Ross COLE is a junior research fellow at Homerton College, Cambridge. He studied at the University of Cambridge, the University of York and the University of Oxford, where he was awarded the Gibbs Prize.

EWA DYNAROWICZ is an assistant professor at the Department of Dutch Studies, University of Wrocław, Poland, where she teaches Cultural Studies with a special focus on the cultural dynamics of migration. She is preparing a book on the Dutch–Iranian migrant writer Kader Abdolah.

ANDREW GREEN is an ethnomusicologist and popular music scholar and is Leverhulme Early Career Research Fellow at the University of Glasgow's School of Culture and Creative Arts. Focused on Mexico, his interdisciplinary research addresses intersections between music, activism, politics and economics.

ANDREW MALL is Assistant Professor of Music at Northeastern University in Boston, where he teaches courses in ethnomusicology, music industry, and popular music. His research interests include Christian congregational and popular musics, music festivals and music industry histories. His writing appears in the edited volumes *Congregational Music-Making and Community in a Mediated Age*, *The Spirit of Praise: Music & Worship in Pentecostal-Charismatic Christianity*, *The Routledge Companion to the Study of Local Musicking* and the journal *American Music*.

FOIRELLA MONTERO-DIAZ received an MMus in ethnomusicology at Goldsmiths, University of London and a PhD in music from Royal Holloway, University of London. Her research focuses on music hybridity, race, class, the elites and social conflict in contemporary Lima, Peru. Currently a lecturer in ethnomusicology at Keele University, Fiorella has published in *Anthropologica* and *Institute of Latin American Studies* series, and is co-editing *Citizenship in the Latin American Upper and Middle Classes: Ethnographic Perspectives on Culture, Politics, and Consumption* (Routledge, in press).

ARIANA PHILLIPS-HUTTON (PhD Cantab) is a musicologist with interests in global pop and art music traditions, performance and philosophy. Previous research has included projects on music and racial reconciliation and the impact of religious ritual

on contemporary classical works; her current project examines the aftermath of violence through the relationship between contemporary music and memory.

TORE STØRVOLD is doctoral research fellow in musicology at the University of Oslo. He is affiliated with the Nordic Sounds: Critical Music Research Network under the direction of Professor Stan Hawkins. His doctoral research project is titled *Sounding Northern Environments: Ecocritical Perspectives on Contemporary Musical Practices in Iceland*. His research has previously appeared in *Popular Music and Society*.
