

Classical Probability in the Enlightenment

Lorraine Daston

What did it mean to be reasonable in the Age of Reason? Classical probabilists from Jakob Bernoulli through Pierre Simon Laplace intended their theory as an answer to this question—as “nothing more at bottom than good sense reduced to a calculus,” in Laplace’s words. In terms that can be easily grasped by non-mathematicians, Lorraine Daston demonstrates how this view profoundly shaped the internal development of probability theory and defined its applications, including gambling, scientific induction, and evaluation of testimony.

Daston contrasts probability theory to the practice of risk in this period, drawing on archival sources concerning insurance and lotteries to reconstruct an alternative rationality of sound judgment under uncertainty.



Are the laws of Nature mere pieces of temporary legislation enacted by ourselves to guide us through the jungles of experience? Are they the same everywhere? Is it even possible that there are no laws of nature—that they’re an illusion? Wide-ranging and interdisciplinary, serious but non-technical, this book traces the evolving concept of laws of Nature, from the magical notions of primitive cultures to the latest ideas about chaos, black holes, and superstrings. The questions it confronts, once the preserve of speculative philosophers, have entered the mainstream of scientific debate. *The World Within the World* offers a fascinating look at where this discussion has been and where it is heading.

PHILOSOPHY OF SCIENCE

Typescript. Typescript, double-spaced, should be submitted (in triplicate) to Professor Robert E. Butts, Department of Philosophy, Talbot College, University of Western Ontario, London, Ontario, Canada N6A 3K7. Typescripts will not be returned unless return postage is prepaid by cheque, money order, International Reply Coupons or Canadian stamps. A bibliographical list of cited references beginning with the author's last name, initials, followed by the year of publication in parentheses, should be headed 'References' and placed on a separate sheet in alphabetical order. Simple citations should then be made by employing in the text, *rather than by footnote*, the reference list by citing author and year of publication, for example, Jones (1958) or (Smith 1974, p. 46). A detailed guide to the new reference style appears in the March issue of each year. Discursive footnotes should be numbered consecutively throughout the typescript. *An abstract (in triplicate) of approximately 100 words must accompany typescript. Typescript must not exceed 9,500 words, including abstract, footnotes and references. A word count must be submitted with each essay. Longer essays will be returned (at the author's expense) to be cut to the acceptable maximum.* All illustrations must be professionally drawn and lettered. All formulas and equations should be put in such a form as to help minimize the number of printed lines in the journal. In the following examples the form on the right is preferable to that on the left:
