# THE MENTAL HANDICAP HOSPITAL TEAM DEAR SIR.

I write as a psychologist who is also a Corresponding Associate of the Royal College of Psychiatrists and one who numbers many psychiatrists among his best friends and most valued colleagues. Nevertheless, I must quarrel with the claim in the Mental Deficiency Section's statement to Council published in your October issue (p 2) that 'Whilst it is true that the psychologist has a large part to play in training, the clinician must remain the co-ordinator of the clinical team to ensure that training principles do not take precedence over humanitarian values'. I know of no evidence to indicate, nor does my experience suggest, that psychologists are any less concerned with humanitarian values than psychiatrists.

If this statement had read '... take precedence over medical needs', the inference concerning coordination would have become more debatable but would have a sounder and more honest basis.
