

mental handicap hospitals being established to ease overcrowding in large hospitals and enable patients to live nearer home, the Board has encouraged the joint training schemes and hopes to see them adopted more widely as other small units are opened. These schemes will ensure that nurses can be trained within the small hospitals themselves.

UNIVERSITY AND TEACHING HOSPITAL DEPARTMENTS

St. George's Hospital Medical School

Clinical, research, and teaching activities are conducted by hospital and medical school staff who together comprise the hospital's Division of Psychiatry. There is a developing area commitment in South-West London based upon Springfield and Atkinson Morley's Hospitals, which will increase further with the completion of the new St. George's Hospital in Tooting, now being built. Undergraduate teaching in psychiatry incorporates a two-month clinical firm, liaison teaching with colleagues in other specialties, and preclinical and first year clinical courses. Postgraduate teaching is based upon three-year appointments at S.H.O./Registrar level with rotation between six firms with varied clinical interests, and additional experience in the general wards and in individual and group psychotherapy. This arrangement will enable a registrar to sit for D.P.M., M.R.C.Psych. and sometimes also M.Phil. by the end of his appointment.

In addition, child psychiatric out-patient services are offered to all sources of referral. Child psychiatry teaching is given to medical students during a two month paediatric firm, and to postgraduates at senior registrar level with rotation to Queen Mary's Hospital, Carshalton and/or a local authority clinic, providing experience with in-patients and all types of out-patient management including child psychotherapy under supervision.

Current department research reflects the different clinical emphases of the senior staff, and includes studies of nutrition, motility, and sleep in normal and psychiatric subjects, life events and a variety of psychological disorders, leucotomy, psychological treatments of phobic and sexual disorders, hypertension, and survey and epidemiological work. The major emphasis is on clinical and evaluative research.

South West Metropolitan Regional Hospital Board

A £100,000 occupational and industrial therapy centre was recently opened at Royal Earlswood Hospital, Surrey. The centre is the first of six being built in the South West Metropolitan region to a standard design.
