BEHAVIORAL SCIENCES AND THE LAW is a new interdisciplinary journal emphasizing the thematic presentation of contemporary and often controversial issues involving the mental health-law interface. Each issue of the Journal will present a specific topic related to both theory and practice of behavioral sciences and the law. Articles will emphasize different perspectives, theoretical orientations, and disciplines. The Journal encourages original creative discussions and synthesis in the designated topic areas, and aims for a better understanding of the complex relationships between law and the behavioral sciences. In presenting often controversial issues from diverse but scholarly viewpoints, the Journal will foster informed debate and expanded understanding in areas of related interests in law, psychiatry and the behavioral sciences.

The Journal encourages the dissemination of current scientific knowledge in the mental health-law interface through the presentation of brief research reports of new advances in the study of forensic mental health. Such research papers will be judged regarding both their relevance to the relationship between mental health and the law, and the clarity and conciseness of their presentation. As with the longer thematic presentations, this shorter section of the Journal encourages new interdisciplinary research of conceptual and practical significance to interested professionals.

The Journal will stress important mental health issues within the framework of the civil and criminal law. It aims to balance theoretical, clinical and research writings to provide the broadest perspectives on pertinent psycho-legal topics of concern to mental health and legal professionals alike.

The Journal now solicits manuscripts for its first two issues:

Issue One — "Malpractice and the Mental Health Professions"
Issue Two — "The Post Traumatic Stress Disorder Syndromes"

Additionally, shorter research reports dealing with empirical studies in the mental health/law area are sought. Thematic manuscripts, sought from both the legal and behavioral science communities, should be 12-24 double spaced 8½ × 11" pages conforming to the editorial style of the Publications Manual of the American Psychological Association (1974) or the **Harvard Law Review**. Research reports should follow the American Psychological Association style. Authors whose papers are accepted for publication will receive 50 free reprints.

BEHAVIORAL SCIENCES AND THE LAW will be published in a 6" × 9" format with four quarterly annual issues totalling approximately 400 pages. The subscription rate for one year — 4 issues — is \$96 for institutional subscribers and \$48 for personal subscribers.
