


SSHA Graduate Student Prize

The Social Science History Association is pleased to offer a \$500 prize, to be awarded biennially, for the best article by a graduate student published in the association's official journal, *Social Science History*. The prize, to be awarded at the association's annual fall meeting, also includes a stipend of up to \$250 to cover the recipient's travel expenses to the conference, as well as a one-year subscription to *Social Science History*.

RADICAL HISTORY *Review*

Disability studies has emerged as one of the most innovative transdisciplinary areas of scholarship in recent years. This *Radical History Review* special issue, "Disability and History," discloses how the definition of "disability" may expose biases and limitations of a given historical moment rather than a universal truth.



Essays examine

- How Western definitions of disability, imposed on Botswana during colonial rule, have shaped local perceptions
- Labor activism among blind workers in Northern Ireland in the 1930s
- Previously untranslated Weimar-era political texts by disabled writers and activists that combat their supposed "complacency" with the Nazi rise to power
- U.S. radical Randolph Bourne as a philosopher of disability politics
- Disabled feminist theater practice in the 1970s and 1980s
