CONTRIBUTORS

Charles M. Atkinson is Arts and Humanities Distinguished Professor of Music (Emeritus) and University Distinguished Professor (Emeritus) at The Ohio State University (USA). He is currently a member of the editorial team for the project 'Corpus monodicum: the Monophonic Music of the Latin Middle Ages'. He has received numerous scholarly awards, among them the Alfred Einstein and the Otto Kinkeldey Awards of the American Musicological Society and the Van Courtlandt Elliott Prize and the Charles Homer Haskins Medal of the Medieval Academy of America. In 2007–8 he served as President of the American Musicological Society.

Harald Buchinger is Chair of Liturgical Studies at the University of Regensburg and a theologian whose research focuses on the reception of the Bible in liturgy, including chant, on the relationship between Christian and Jewish liturgy, and on the development of the liturgical year. Having obtained a diploma in Church Music, he studied Theology in Vienna and Jerusalem (Mag. theol., Dr. theol., Vienna University) and spent three years in Rome engaged in post-doctoral studies and research. He has published a two-volume monograph, *Pascha bei Origenes* (Innsbruck, 2005), and numerous articles. He regularly gives lectures, notably in Jerusalem and Leuven, and was a Fellow at the Institute of Sacred Music and Visiting Professor of Liturgical Studies at Yale University in 2012–13.

Jan Ciglbauer is a postdoctoral researcher at the Charles University in Prague. He explores the tradition and historical context of Latin and vernacular songs in Bohemia and central Europe from the late thirteenth to the early sixteenth century. He focuses on how the repertoires were shaped by institutions, knowledge, education and confession. He is the founder and editor of Cantio.cz.

Peter Jeffery is Michael P. Grace Chair of Medieval Studies and Professor of Musicology and Ethnomusicology (Emeritus), and the former Music Department Chair at the University of Notre Dame, as well as Scheide Professor of Music History (Emeritus) at Princeton University. He was the first musicologist to receive a 'Genius Award' Fellowship from the John D. and Catherine T. MacArthur Foundation (1987–92). An early article received the Alfred Einstein Award from the American Musicological Society; volume 1 of his book *Ethiopian Christian Liturgical Chant* (co-authored with Kay Kaufman Shelemay) received the 1994 Paul Revere Award for Graphic Excellence from the Music Publishers' Association. He was recently appointed a Fellow of the Medieval Academy of America.

Svetlana Kujumdzieva is Professor of Medieval Music at the National Musical Academy 'Prof. Pancho Vladigerov' and Theological Faculty of the Sofia State University 'St Clement of Ohrid', and academician at the Bulgarian Academy of Sciences (2021).

Her interests are in Byzantine and Slavic medieval music, notations, palaeography, codicology, music history and theory in the Middle Ages and the Balkan National Revival of the eighteenth and nineteenth centuries. She has published twelve monographs and more than 150 articles in Bulgaria, Austria, Denmark, Finland, France, Germany and the United States. She is a member of many national and international scientific organisations.

Elizabeth Eva Leach is Professor of Music at the University of Oxford and the author of *Sung Birds* (2007), *Guillaume de Machaut* (2011) and *Medieval Sex Lives* (2023), all published by Cornell University Press. A further monograph with Cornell, on Richard de Fournival's *Bestiaire d'amours*, co-authored with Jonathan Morton, will be published in 2025. Much of her work is available at https://eeleach.blog/.
