Starting in 2026, we're moving to a Gold Open Access model:

- Articles will continue to be free to read for everyone.
- The journal will now be able to benefit from funding that has been provided by funding bodies and academic institutions for the purpose of supporting open access research.
- Our publishing partner, Cambridge University Press, supports this transition with a wide network of funding arrangements.

### No Author Left Behind

We're committed to equity in publishing:

- No author will ever have to pay personally to publish.
- Waivers and access initiatives will be in place for authors not covered by funding.
- Lack of funding will never be a barrier to publishing in *BJPsych Bulletin* and *BJPsych International* or affect your chances of publication in any way.
