## REPORT

of the

AMERICAN POLITICAL SCIENCE ASSOCIATION

## COMMITTEE ON PROCEDURES

The task assigned us by the President and Council is to make "recommendations for procedures and rules for the conduct of the Council and Business Meetings in September, 1969." The recommendations we now submit are designed to assure both maximal participation by the association's members and orderly conduct of the business of the Association. We have so organized the body of the report that the Council may adopt a set of standing rules applicable not only to the 1969 meetings but to all future meetings, subject, of course, to future amendment.

The Constitution of the Association is explicit on many procedural matters and clear in intent on most others. The rules we propose are consistent with the Constitution. Our recommendations go beyond rules to arrangements that we suggest the Association's officers and its members follow in order to facilitate timely initiation of and deliberation on matters to be considered in September and to assure that the Association's business can then be transacted within the time periods allotted for the Council meeting and Annual Business Meeting (periods that are substantially longer than in prior years).

### *Adoption and Publication of Procedural Rules*

The Constitution provides that, subject to the overriding authority of the Association membership (as noted below), "the Council shall be the governing body of the Association and have general charge and supervision of its business and interests in accordance with this Constitution," and "may . . . adopt the rules for the regulation of the Association's business." It directs that "The Council and the officers shall make every effort to acquaint the members with the business of the Association and with the issues involved in the agenda of the Annual Business Meeting, and to provide sufficient time at business meetings for deliberations and decisions." It also provides that "The highest authority for deciding the policies and managing the affairs of the Association is the membership of the Association duly assembled in the Annual Business Meeting, or in a special meeting duly called. It . . . may confirm, revise, or repeal the action of the Council, the Executive Committee, or any officer." (Art. VIII, Secs. 1 and 2).

We recommend that:

a. The Council adopt procedural rules for the receipt and conduct of business at the An-

nual Business Meeting and at the Council Meeting immediately preceding the Annual Business Meeting.

b. The rules adopted be published and distributed to all members of the Association in the August, 1969, issue of *P.S.*, be distributed at the beginning of the 1969 Annual Business Meeting, and thenceforth be in effect unless a motion to amend or delete any rule or to substitute a different set of rules is made and passed by majority vote of the Council or the Annual Business Meeting.

c. Prior to Council adoption of procedural rules for the Annual Business Meeting and the Council meeting, this report of the Committee on Procedures be published and distributed to the membership of the Association, with a request for prompt communication by members of their comments and suggestions.

It should be noted that the rules adopted for receipt and conduct of business at the September, 1969, Council meeting will be controlling, as that meeting will have been concluded before its procedural rules could be considered at the Annual Business Meeting.

#### 1. Annual Business Meeting: Attendance and Participation

The right "to attend and to participate in the Annual Business Meeting of the Association" is constitutionally accorded "all members, upon payment of such registration fee as the Council may approve." (Art. III, Sec. 7).

We note, for its relation to this group and subsequent groups of recommendations, that the Annual Business Meeting in 1969 will occur in two time periods: Part I, Wednesday, September 3, from 4 to 6 p.m., and Part II, Thursday, September 4, from 8:15 p.m.

We recommend rules providing that:

1.1 Attendance at and participation in the Annual Business Meeting shall be restricted to members of the Association who have paid the approved registration fee.

1.2 Members upon registration shall be issued nontransferable badges readily distinguishable from badges issued nonmember registrants and representatives of the Press.

1.3 The Registration Desk shall be open (in addition to the normal registration hours) during the first hour of the Annual Business Meeting or, if the Meeting is held in separate time periods, during the first hour of each such period.

We also recommend that:

a. The Council establish the 1969 Annual Meeting registration fee for members at no higher level than that of 1967 and 1968 (\$5.00).

b. Members be encouraged to preregister by mail for the Annual Meeting, if such preregistration will expedite the confirmation of membership status and the operation of the Registration Desk.

c. The Registration Desk be equipped for expeditious confirmation of membership in the case of members who have failed to take advantage of the preregistration procedure.

#### 2. Conduct of the Annual Business Meeting

We recommend rules providing that:

2.1 The agenda of each Annual Business Meeting shall be as follows:

(1) Proposed Constitutional Amendments  
—to be considered in order of submission during the preceding year, subject to grouping of proposed amendments relating to the same topic (with the order of each group determined by the date of submission of the earliest submitted proposed amendment in the group).

(2) Resolutions  
—to be considered in order of submission during the preceding year, subject to grouping of resolutions relating to the same topic (with the order of each group determined by the date of submission of the earliest submitted proposed resolution in the group).

(3) Election of Officers  
—provided that if the Annual Business Meeting is scheduled to take place in separate time periods, such elections shall be held in the last such period.

(4) Other business  
—reports of officers and committees—  
new business.

2.2 The Council shall prepare and publish a full agenda for each Annual Business Meeting, including the text of all proposed amendments and resolutions, with statement of the Council's recommendation on each, such full agenda to be made available to members at the beginning of the Annual Business Meeting.

2.3 On any proposed constitutional amendment or resolution, each speaker shall speak only once and be allotted a maximum of five minutes, except that the first signer of a proposal for an amendment or resolution (or his designee) shall be allotted an additional five minutes in which to respond to comments made during the floor discussion.

2.4 The President shall recognize alternately proponents and opponents of the proposed amendment or resolution being considered, so long as members of each group seek recognition, subject to the previous question being ordered.

2.5 Debate on any proposed amendment or resolution shall close and a vote be taken when a member moves the previous question and a majority supports the motion, *provided* that if the chair has not previously afforded an opportunity for recognition to the first signer of the proposal or his designee, one opponent (if any), and (if an opponent speaks) the first signer or designee for response, he shall do so and then put the motion for the previous question to vote.

2.6 Written reports of the officers and committees of the Association shall be reproduced and made available for all interested members attending the Annual Business Meeting.

2.7 No oral reports of officers and committees of the Association shall be presented at the Annual Business Meeting, save for the report of the Chairman of the Nominating Committee. However, an opportunity for members to question and discuss the written reports shall be provided as the last item on the agenda of the Annual Business Meeting.

We also *recommend* that:

a. An adequate number of tellers be designated by the President.

b. A member of the American Institute of Parliamentarians who is not a member of the American Political Science Association be engaged to assist the President in the conduct of the 1969 Annual Business Meeting.

### 3. *Proposed Resolutions and Amendments: Signers, and Deadlines for Submission*

The Constitution requires that every resolution and proposed constitutional amendment (unless initiated by the Council itself) shall be referred to the Council for consideration and recommendation, and that every resolution and proposed amendment, regardless of Council recommendation on it, shall be submitted by the Council to the Annual Business Meeting for action thereon. Proposal of an amendment to the Constitution must be by ten members. (Arts. VIII and IX). The Constitution being silent on the point, a resolution may be proposed by a single member. In practice proposed resolutions may, and often do, record a number of members as co-sponsors, rather than the single name required; similarly the document proposing a constitutional amendment may carry more than the ten names required.

We note here, for understanding of our recommendations, that the Council's meeting this Fall will begin at 9:30 a.m. on Sunday, August 31, and continue Monday, September 1, and, if necessary, Tuesday, September 2.

In view of experience during the 1968 meet-

ing, procedural rules are necessary to assure full and orderly consideration of proposed resolutions and amendments. First, no resolution or proposed amendment should bear the names of persons who in fact have not authorized use of their names for these purposes. In 1968 a resolution of this character was submitted (though later withdrawn); apart from other questions about such practice, official duplication and circulation of such a document exposes the Association to the possibility of legal action by those incorrectly listed.

Second, the business to come before the Council needs to be known in advance of its opening session so that documents can be reproduced, related resolutions and proposed amendments be grouped by topic, and an agenda be prepared. The Council's deliberations and actions cannot well proceed and its work be completed if, as in 1968, resolutions and amendments are being drafted and delivered by Association members throughout the Council meeting, often after Council consideration of the relevant topic has been concluded or in reaction to the course of Council discussion and action on the topic. A deadline for receipt of resolutions and proposed amendments therefore seems necessary.

We *recommend* rules providing that:

3.1 No resolution or proposed constitutional amendment shall be considered by the Council or transmitted to the Annual Business Meeting unless it bears the personal signature of the proposer in the case of a resolution or the personal signatures of ten proposers in the case of a constitutional amendment, except that in the latter case any of the proposers may authorize their identification as proposers by a signed communication to the Association specifically identifying the proposed amendment.

3.2 The Council shall delete all listed names of supporters beyond those constitutionally necessary for a resolution or proposed amendment with the exception of names personally signed by such supporters or names of listed supporters who authorize such use through individual, signed communications separately received by the Association, specifically identifying the resolution or proposed amendment.

3.3 All resolutions and proposed amendments shall be received by no later than noon of the day preceding the opening of the Council meeting, and no others (except those formulated by the Council itself) shall be considered by the Council and the Annual Business Meeting.

We also *recommend* that:

a. Members of the Association be encour-

aged to submit resolutions and proposed amendments as early as possible, and those submitted by July 1, 1969, be printed in the August issue of *P.S.* if they have not already appeared in earlier issues.

b. Members be advised to address their resolutions and proposed amendments to the Association's national office, if mailed prior to August 20th, and after that date to the Secretary at the official convention hotel (in 1969, Professor Bernard L. Kronick, Secretary, American Political Science Association, Commodore Hotel, New York, N.Y. 10017).

c. Members be advised that under Rule 3.3, the 1969 deadline for receipt of resolutions and proposed amendments is noon of Saturday, August 30th.

#### 4. *Nominations and Elections of Officers*

The Constitution provides that "The elective officers, except the President, shall be chosen by a majority vote of the members of the Association attending the Annual Business Meeting, a quorum being present," directs the President to appoint a Nominating Committee, which submits to the Annual Business Meeting one nomination for each elective office to be filled (President-Elect, three Vice-Presidents, a Secretary, a Treasurer, and eight elected members of the Council), and provides that "Additional nominations, sponsored by at least 10 members of the Association, may be offered from the floor at the Annual business Meeting, upon 24 hours' advance notice to the Secretary." (Arts. IV and V). However, the Constitution is silent on the procedure at the Annual Business Meeting in the event that a contested election fails to provide a majority for any candidate on the first vote to fill an office.

We *recommend* rules providing that:

4.1 Each notification to the Secretary of proposed additional nominations (whether for a slate of nominees for all offices, for a set of nominees for certain offices, or for a nominee for one office) shall be valid only if it carries the personal signatures of at least ten members, or if listed members who have not signed the original document certify their co-sponsorship by signed individual communications to the Secretary indicating specifically the nominations sponsored.

4.2 The Secretary shall arrange for a clearly identified box to be placed at or near the Registration Desk for submission of nominations, any individual certifications by members of authority for their names' inclusion on an original nominating document, and designations of speakers in support of nominations;

and such box shall be removed 24 hours before the beginning of the Annual Business Meeting or the separate time period thereof at which the election of officers is scheduled to take place.

4.3 In the Annual Business Meeting's consideration of candidates for offices to which nominations additional to those of the Nominating Committee have been submitted,

- (1) Each speaker shall be limited to five minutes.
- (2) Not over two speeches shall be made on behalf of any one candidate.
- (3) Priority in recognition shall be accorded the one or two speakers designated by the Chairman of the Nominating Committee (in the case of its candidates) and the one or two speakers designated by the first signer of each additional nomination, such designations to be submitted to the Secretary of the Association 24 hours in advance of the Annual Business Meeting's consideration of nominations.
- (4) No person who requests withdrawal of his name shall be considered a nominee.

4.4 In the conduct of contested elections for officers at the Annual Business Meeting,

- (1) Each office or set of identical offices shall be voted on separately.
- (2) Voting shall be by marking of printed ballots that list all candidates for the particular office or set of identical offices.
- (3) Each voting member shall vote for candidates in a number not exceeding the number of vacancies to be filled at the time of a poll.
- (4) Each candidate receiving a majority vote shall be declared elected.
- (5) If on the first poll on an office or a set of identical offices fewer candidates receive a majority than there are posts to be filled, a second poll shall be taken in which the choice shall be between the candidates receiving the largest number of votes short of a majority, such candidates to be no more than twice the number of posts remaining to be filled. Should the second poll fail to provide the majority or majorities required to fill a set of identical offices, balloting shall continue, with the candidate with the fewest votes on the preceding poll being dropped in each succeeding poll, until the election for the set of offices is completed.

We also *recommend* that:

a. Groups of members prepared to do so be encouraged to notify the Secretary (in the mode indicated in Rule 4.1) by August 15 of additional nominations. (In 1969, such early nominations should be addressed to Professor Bernard L. Kronick, Department of Political Science, University of Santa Clara, Santa Clara, California 95053).

b. Members be advised that in 1969 the deadline for submission of nominations (Rule 4.2), and for designation of speakers in behalf of candidates (Rule 4.3 (3)) is 8:15 p.m., Wednesday, September 3.

c. At or before the time scheduled for the Annual Business Meeting's consideration of nominations, a full list of offices and nominees be distributed to members attending the Meeting.

Two additional observations may assist in interpretation of our recommendations. First, Rule 4.4 (1) does not preclude a motion to elect all candidates of the Nominating Committee for offices for which no additional nominations have been submitted. Second, consideration of Rule 4.4 (5) may be aided by the reminder that in the case of the three Vice Presidencies and the eight Council memberships all candidates for each *set* of offices (if more numerous than the number of posts) are in competition with all others, and the further

reminder that election of any candidate constitutionally requires a majority vote.

Because Council approval and publication of this suggestion would be too late for effectiveness, the Committee on Procedures directly suggests to groups of members intending to make additional nominations that they would assist the membership this year if their nominations reached the Secretary by June 30 so that they might be published in the August issue of *P.S.* (See Recommendation "a" immediately above).

#### 5. *Council Meeting: Observers*

At its September 1968 meeting, the Council instructed the officers of the Association to arrange facilities for members to attend Council meetings as observers. No formal recommendation by us is required.

We interpret the instruction to mean that:

a. Only Association members (who, however, need not be registered for the Annual Meeting) are eligible to attend.

b. Members attending as observers may not participate in the Council's discussions.

c. The membership should be advised in advance of the opportunity to attend.

### CONGRESSIONAL FELLOWSHIP PROGRAM

The Association has announced 17 winners in the national competition for the 1969-70 Congressional Fellowship Program.

The winners—eleven political scientists, five journalists, and one law school professor—will come to the Nation's Capitol for a year of full-time work in the offices of Senators and Members of the House of Representatives.


Each winner will receive a minimum stipend of \$6,000 for the year, plus travel expenses. The program is financed by a Ford Foundation grant, and services of the Fellows are free of charge to the Congressional offices in which they work.

Sponsored by the Association since 1953, the purpose of the Congressional Fellowship Program is to give outstanding young academicians and political journalists an opportunity to further their knowledge of the national legislative process.

The Congressional Fellows begin the program in mid-November with a six-week orientation period. They will start working in Congressional offices of their choice about January 1, 1970. The program ends August 15, 1970.

The 17 winners were selected on the basis of superior academic training and experienced. Final selections were made by an Advisory

### STATE AND LOCAL INTERNSHIP PROGRAM

The Association's State and Local Government Intern Advisory Committee has announced 13 grants under a program sponsored by the Ford Foundation. The Committee is chaired by Charles B. Hagen, University of Houston. Other members are Paul L. Beckett,

Washington State University; Franklin L. Burdette, University of Maryland; Chester B. Earle, American University; Thomas A. Flinn, Ohio State University; and Donald G. Herzberg, Eagleton Institute.

The Committee made 13 grants, six of which were renewals. Receiving grants were Case Western Reserve University, Florida (University of Florida-Florida State University), Indiana University, Iowa (University of Iowa and Iowa State University), University of California, Davis, University of Tennessee, Vanderbilt University, West Virginia University, University of Maryland, University of Texas, University of Utah, Washington University (St. Louis), and the University of Washington.

The grants are made for the purpose of supporting graduate internships at the state and local level, to provide recipients the opportunity to conduct research and observe the conduct of government.

### PUBLIC AFFAIRS REPORTING AWARDS

Forty-three reporters have been honored for excellent reporting of public affairs in a program sponsored by the Association. Special plaques will be presented to the reporters, as well as to their newspapers or television stations. Winning reporters will also attend seminars conducted by leading political scientists, journalists, and public officials. One seminar will be held in June and another in August. More entries were submitted in 1969 than in any previous year for the program, which is financed by a grant from the Ford Foundation.
