**Joseph Dyer** taught music history at the University of Massachusetts Boston until his retirement in 2001. His research interests and publications have focused on topics in the fields of chant, liturgy (especially Rome in the Middle Ages), monasticism, performance practice, medieval music theory and intellectual history. He is a Fellow of the Royal School of Church Music.

**Jamie Reuland** is Assistant Professor of Music at Princeton University. Her work focuses on the intellectual, aesthetic and political history of music in the later Middle Ages, with a particular emphasis on Italy and the Mediterranean. She has been the recipient of numerous grants and awards, from the American Council of Learned Societies, the Mellon Foundation, the Fulbright Foundation and the Medieval Academy of America, among others. From 2014 to 2015, she was a Mellon Fellow in the Humanities at Stanford University.

**Andrew Wathey**, CBE, is Vice-Chancellor of Northumbria University, Newcastle, and was previously Professor of Music History at Royal Holloway, University of London. His research has focused on the social and cultural history of music in late medieval England and France, and manuscript studies. He is a co-founder of the *Digital Image Archive of Medieval Music (DIAMM)*, and is currently working on a study of Philippe de Vitry.
