¶ The Berkshire Conference of Women Historians will award its annual prizes for the best book and the best article in any field of history written by an American woman and published during 1982. Submissions for the book award should be sent to Jean Christie, 34 Bellingham Lane, Great Neck, New York 11023, and for the article award to Kim Phillips, Department of History, University of Connecticut, Avery Point, Groton, Connecticut 06340. Two copies of the book or article are required. Deadline for submission is February 1, 1983.

The Berkshire Conference also announces the inauguration of the Berkshire Summer Fellowship at the Mary Ingram Bunting Institute of Radcliffe College. The purpose is to provide financial support for summer research and writing. The stipend is \$1,500 and may be held for one or two months, at the recipient's choice. The recipient will be the Berkshire Fellow at the Bunting Institute and must be in residence in Cambridge for not less than one month during the period June 15 to September 1. Office space, access to libraries and other facilities of Radcliffe and Harvard are provided. All women historians at the post-doctoral level are eligible. Applications will be judged on scholarly significance and quality of the research proposal. Application deadline for summer 1983 is February 15. Applicants will be notified by May 1, 1983. ¶ Die Stiftung Volkswagenwerk hat die Mittel zur Durchführung eines Gastdozenten-Programms "Emory German Studies" für die Jahre 1983-1985 bewilligt. Innerhalb dieses Programms sollen pro Jahr zwei deutsche Dozenten der Fächer Germanistik/Geschichte/Philosophie die Möglichkeit erhalten, an der Emory University, Atlanta, für je ein Semester über deutsche Kultur- und Geistesgeschichte zu lehren. Das Programm sieht Kurse innerhalb des Graduate Institute of the Liberal Arts der Emory University vor, die sich mit allgemeinen Tendenzen der deutschen Literatur, Philosophie und Geschichtsschreibung im 19. Jahrhundert sowie mit problem-geschichtlichen Längsschnitten und Einzelthemen, wie Romantik, Historismus, Naturwissenschaft und Technik, Politische Philosophie usw. befassen. Die Gastdozentur erstreckt sich auf die Monate September bis Mitte Dezember bzw. Mitte Januar bis Mitte Mai. Eine gewisse Flexibilität ist möglich, um den Anschluss an das jeweilige deutsche Semester zu erhalten. Das Goethe-Institut am Ort ist

auf eine enge Kooperation mit den Gastdozenten eingestellt und vermittelt Vortragsreisen an Universitäten der engeren und weiteren Umgebung.

Voraussetzungen: Habilitation in den Fächern Germanistik/Geschichte/Philosophie; Forschungsschwerpunkt 19. Jahrhundert; völlige Beherrschung des Englischen als Unterrichtssprache; nach Möglichkeit Lehrerfahrung im englisch-sprechenden Ausland. Eine deutsche Kontaktstelle ist mit dem Institut für Philosophie der Ruhr-Universität Bochum, Professor Dr. Frithjof Rodi (Universitätsstrasse 150, 4630 Bochum 1) verbunden und erteilt auf Wunsch weitere Auskunft.  The Association for the Bibliography of History, in conjunction with the Department of History and the Lauinger Library at Georgetown University, has organized the National Registry for the Bibliography of History. The registry will collect, record, and disseminate information about bibliographic projects in all fields of history, unpublished or in progress, in the United States and Canada.
