## Research in Child Psychiatry

A grant of £250,000 over a period of six years for operational research into maladjustment in children has been made by the Department of Education and Science. ## CORRESPONDENCE

DEAR SIR,

I am at present engaged in international research work, which is centred in Paris. I have only now come across the report by Dr. D. Joyce Galbraith (News & Notes, Feb. 1972, pp. 13-19) on the R.M.P.A. Study Tour in France, in September 1969.

I must, I fear, regard as deplorable the error, in the section on Paris, in my colleague's account (pp. 14-15). She refers to a visit to 'La Roche Vocauld—a day hospital in Paris'.

This institution is, in fact, the 'Institut de Psychiatrie La Rochefoucauld'—(so named because it is situated in the Rue de La Rochefoucauld, called after the famous seventeenth-century author of memoirs and maxims)—which comprises an excellent day hospital, as well as an excellent out-patient consultant service; it also comprises a Research and Teaching Centre' ('Centre de Recherche et d'Enseignement') which is associated with the 'Laboratoire de Psychopathologie sociale' of the École Pratique des Hautes-Études, Paris University.

I am undertaking research in association with my French colleagues at this Institute. What is more, an international Study Group was held there (under the chairmanship of Dr. L. Chertok, senior consultant of its Psychosomatic Department) in October 1968. This Study Group, which was convened for the purpose of planning a cross-cultural research programme on psychiatric day hospitals, comprised representatives from France, the U.S., Canada, U.S.S.R., Nigeria, and the U.K. The latter was in fact represented by two of Dr. Galbraith's compatriots, Professor Carstairs and Dr. E. A. M. Wood (Psychiatric Consultant to the Day Hospital, Royal Edinburgh Hospital). The (then) Chief of the Mental Health Section, W.H.O. (Prof. Baan) was also present.

It appears to me most regrettable that the author of the report should have failed to ascertain the true name of an institution the party was visiting, either by referring to the programme of the Tour or a prospectus of the Institute or simply by enquiry.
