WPSA Announces 1994 Awards

The Western Political Science Association Annual Meeting was held March 10–12 in Albuquerque, New Mexico, and a number of awards were presented. The Pi Sigma Alpha award was given to **Robert A. Bernstein**, Auburn University, for his paper "Directing Electoral Appeals Away from the Center: Issue Position and Issue Salience."

Mary L. Shanley of Vassar College was presented the Betty Nesvold Award by the Women and Politics

section for her paper "Fathers' Rights, Mothers' Wrongs? Reflections on Unwed Fathers' Rights, Patriarchy, and Sex Equality." The award on Black Politics was given to **Benjamin Radcliff** and **Martin Saiz** of Notre Dame University for their paper "Turnout, Race, and Public Policy in the American States." Because of the limited number of submissions this year, the Dissertation award was not awarded and will be delayed until the 1995 Annual Meeting. Dissertations eligible for consideration this year will be included in the pool next year.
