

SUSAN C. BOURQUE is Professor of Government and Director of the Project on Women and Social Change at Smith College. She coauthored *Women of the Andes: Patriarchy and Social Change in Two Peruvian Towns and co-edited Women Living Change and Learning about Women: Gender, Politics, and Power*. Her current research focuses on gender, the state, and development in Latin America.

KAY B. WARREN, Professor of Anthropology at Princeton University, wrote *The Symbolism of Subordination: Indian Identity in a Guatemalan Town and coauthored Women of the Andes: Patriarchy and Social Change in Two Peruvian Towns*. She is currently studying ethnicity and cultural constructions of violence in Guatemala and writing on women and international development in Latin America.
