Kenneth Reeves Essay Prize

The Society for Psychosomatic Research invites entries for the award of the Kenneth Reeves Essay Prize of £50 for an essay on a psychosomatic subject, not more than 5,000 words in length. Applicants should have been qualified in their discipline for not more than ten years. Preference will be given to original work. It is expected that a lecture based on the prize essay will be given by the successful applicant at a meeting of the Society in April 1977. Application forms are obtainable from the Hon Secretary: Dr Jean Harrison, Department of Psychological Medicine, St Bartholomew's Hospital, London EC1. The closing date is 31 December 1976.

The Society for Psychosomatic Research was founded in January 1955, in London. Its aims are (1) to promote the understanding of psychosomatic relationships by providing a congenial forum for discussion by workers in the various disciplines of medicine and its allied sciences, and (2) to encourage the presentation of work nearing completion for critical debate.

Its purpose is to further interchange of ideas among those with special experience in the fields of social and clinical medicine, applied psychology, psychiatry, psychoanalysis, biology, physiology and genetics, in the belief that such interchange will bring about a wider understanding of the human organism in health and disease. The scope of its inquiries is wide; it is the whole range of interaction between man, his environment and society, as it relates to the production of illness.

The Society holds monthly evening meetings open to members and their guests, as well as an annual two-day Conference in the autumn.

A NEW VIDEOTAPE
