# The Contributors

RAFFAELLA BIANCHI is a research fellow at REDESM (International Research Centre on Religion, Law and Economy in the Mediterranean Area – Università degli Studi dell’Insubria, Como). After writing a PhD on opera and the Risorgimento at PHIR (Loughborough University), she worked for six years as assistant professor in political science and international relations in Turkey. She has published on opera and politics, in particular: ‘Space and hegemony at La Scala (1776–1850)’ (*The European Legacy*). Her research interest lies in music and politics.

KAI ARNE HANSEN holds a PhD in critical musicology from the University of Oslo, where he is currently employed as a research and teaching fellow. His main research interests include pop music, gender, audiovisual aesthetics and personal narrativity. His work has been published in *Popular Music and Society* and *The Routledge Research Companion to Popular Music and Gender*, and he is currently co-editing a collection of essays on contemporary approaches to popular music analysis that is forthcoming with Palgrave Macmillan.

STAN HAWKINS is Professor of Musicology at the University of Oslo and adjunct professor at the University Agder, Norway. He is author of *Settling the Pop Score* (2002), *The British Pop Dandy* (2009), *Prince: The Making of a Pop Music Phenomenon* (co-author Sarah Niblock, 2011), and *Queerness in Pop* (2016). Edited volumes include *Music, Space & Place* (co-editors Sheila Whiteley and Andy Bennett, 2004), *Essays on Sound and Vision* (co-editor John Richardson, 2007), *Pop Music and Easy Listening* (2011), *Critical Musicological Reflections* (2012) and *The Routledge Research Companion for Popular Music and Gender* (2017). He is series editor of Routledge’s *Ashgate Popular and Folk Music Series*. In 2017 he was elected an academy member of the Norwegian Academy of Science and Letters.

CATHERINE HOAD lectures in popular music studies and creative media practice in the College of Creative Arts, Massey University, Wellington. She received her PhD in Media, Music and Cultural Studies from Macquarie University in 2016. Catherine’s research focuses on the intersections of race, gender and identity in metal music scenes and practices, with wider interests in fan cultures, scene studies and popular music and national identity. She is currently editing a collection on Australian heavy metal scenes, practices and cultures.

MIKKO KETOVUORI works as a University Lecturer of music education in the teacher education department at the University of Turku, Finland. His earlier research has dealt broadly with arts, music and their role in education and in society. Ketovuori has given international keynotes and lectures in places such as India, Singapore, the USA, Spain, Austria, Czech Republic and Romania.

MARIA KOUVAROU holds a PhD from Durham University. Her previous publications include ‘Deconstructing the “bodies”: reading the feminine approach to the Sex

Pistols', *Popular Music and Society* and 'American rock with a European twist: the institutionalization of rock 'n' roll in France, West Germany, Greece, and Italy (20th Century)', *Historia Critica*. She is currently an independent researcher focussing on local music networks and the everyday politics of music, and editor-in-chief of a local rock magazine.

MATT LAMPERT is the director of research at the Socionomics Institute, a research center dedicated to using data on social mood to understand and anticipate cultural trends. He is a contributing author to the books *The Socionomic Theory of Finance* and *Socionomic Causality in Politics*, and a contributing editor to the book *Socionomic Studies of Society and Culture*.

JOHN STREET is a professor of politics at the University of East Anglia. His most recent books are *Music and Politics* (Polity, 2013) and (with Sanna Inthorn and Martin Scott) *From Entertainment to Citizenship: Politics and Popular Culture* (Manchester University Press, 2013). Having spent the last few years researching (separately) punk and copyright policy, he is now focusing on protest music in the present and the past.

ALEXANDRA SUPPER is an assistant professor in the Department of Technology and Society Studies at Maastricht University. Her research interests include the role of the senses (especially hearing) in scientific practice, the culture of academic conferences, and the emergence and consolidation of scientific disciplines and interdisciplinary communities.

DAVID WILKINSON is Lecturer in English at Manchester Metropolitan University. He is the author of *Post-Punk, Politics and Pleasure in Britain* (Palgrave Macmillan, 2016) and is involved with the Interdisciplinary Network for the Study of Subcultures, Popular Music and Social Change. His current research focuses on countercultural legacies in contemporary culture and politics.

MATTHEW WORLEY is professor of modern history at the University of Reading. He has written several books and articles on British politics and is currently researching the links between politics and youth culture. A monograph, *Nowhere/Boredom: Punk, Politics and British Youth Culture, 1976–84*, was published by Cambridge University Press in 2017.
