AMERICA EN CIFRAS 1970

The Organization of American States has published a series of eight volumes (paperback) which survey Latin American for 1970. ARCHAEOLOGY OF NORTHERN MESOAMERICA

Archaeology of Northern Mesoamerica comprises the tenth and eleventh volumes in the fourteen-volume *Handbook of Middle American Indians*, published in cooperation with the Middle American Research Institute of Tulane University under the general editorship of Robert Wauchop. Volume editors of *Archaeology of Northern Mesoamerica* are Gordon F. Ekholm and Ignacio Bernal.

Volumes 10 and 11 describe the pre-Aztec and Aztec cultures of Mexico, from central Veracruz and the Gulf Coast, through the Valley of Mexico, to western Mexico and the northern frontiers of these ancient American civilizations. Thirty-two articles, illustrated and accompanied by bibliography and index, make up these two volumes. The price of the two volume set is \$30.00. BLAINE ETHRIDGE—BOOKS

A new publisher of books useful to Latin Americanists has made its appearance. Blaine Ethridge—Books, since 1965 a specialist dealer in out-of-print and imported new books in the social sciences concerned with Middle and South America and the Caribbean, has reissued a number of standard Latin American titles.

The list includes Hilton's *Who's Who in Latin America* (3rd edition, originally published 1945–51), Grismer's *Reference Index to Twelve Thousand Spanish American Authors*, and Ewbank's *Life in Brazil*. The Praeger Special Studies (PSS) program makes available to the academic, governmental, and business communities significant policy-oriented research and specialized material in three areas: International Economics and Development, International Politics and Public Affairs, and U.S. Economic and Social Development. Since its inception in 1964, the PSS program has grown to include more than 350 titles; another 110 books will be published during this fiscal year. During the past seven years, many of these titles have been listed in the Publications sections of LARR. VOZ VIVA DE AMERICA LATINA

The Universidad Nacional Autónoma de México in collaboration with the Unión de Universidades de América Latina is preparing a series of records containing readings of historical documents and the works of the most outstanding authors in Latin American literature. Historical documents will be selected from all periods of Latin American history. Benito Juárez's "Páginas autobiográficas" and "Manifiesto de julio de 1867" have already been recorded by Antonio Carrillo Flores. José Martí's "Nuestra América y Carta a Manuel Mercado" was read by Juan José Arreola.

Literary selections will include several of the poems of Rubén Darío, in the

voices of Jaime Torres Bodet and Rubén Bonifaz Nuño and some of the poetic work of César Vallejo recorded by Claudio Obregón. Among the authors who have recorded their own works for this series are: Pablo Neruda, Miguel Ángel Asturias, Alejo Carpentier, Juan Carlos Onetti, Julio Cortázar, Gabriel García Márquez, Manuel Rojas, Mario Vargas Llosa, Jorge Luis Borges, Ernesto Cardenal, Sara de Ibáñez, Jorge Zalamea, and Augusto Monterroso. Additional records in this series are in preparation.

NEW AND SUSPENDED PERIODICALS

In 1969 the Instituto de América Latina of the Academy of Sciences of the USSR began publication of a bi-monthly journal *América Latina*. The journal includes studies carried out by Soviet and Latin American researchers, reports, periodical notices, literary studies, statistical summaries, and discussions on Latin American topics.

Anais de História is the official publication of the Departamento de História da Faculdade de Filosofia, Ciências e Letras de Assis, São Paulo, Brasil. The first issue of the journal (Ano I, 1968/69) appeared in 1971. The publication includes articles, reports, and book reviews written by faculty members. Boletín CLACSO is a quarterly publication of the Consejo Latinoamericano de Ciencias Sociales. The *Boletn* contains bibliographical listings with summaries and analyses (in German) of recent monographs and articles on Latin American economic and social development. Ciencia Interamericana is now in its thirteenth volume—not a new periodical. It is unique, however, as a scientific journal which focuses on Latin American scientific development and technology. *Ciencia Interamericana* is a bilingual periodical published by the Organization of American States. The journal is made up primarily of brief reports and articles on Latin American scientific development, the scientific community, application of technology to socio-economic development, and a variety of related issues. Sur, the oldest literary journal of Latin America in continuous existence suspended publication in 1971. Its director, Victoria Ocampo, announced the suspension of the Argentine magazine and revealed that twice a year a volume would be published dedicated either to various anthologies or to a special topic.
