Not just another exercise in analogy between the different arts, this book is a genuinely interdisciplinary study designed to show how in the late sixteenth and early seventeenth centuries 'the way English poets looked at pictures influenced in some respects the way they wrote their poetry'. **Lucy Gent** breaks new ground in her exploration of the visual and verbal sensibilities of an audience unused to the new art of perspective and chiaroscuro, indeed to the very idea of art-painting. She records how English spectators were struck by this new art's powerful capacity for illusion and how, at the same time as their language developed to accommodate its techniques and effects, their conception of the nature and place of art altered too; the implications for English poets, including Shakespeare, are suggestively analysed. A substantial appendix complements the main essay by surveying the ownership and distribution of books on art, perspective and architecture in English Renaissance libraries. This study will be of interest to students of literature (and the history of the language), art history, architectural history, and bibliography alike.

**The Laboring Classes in Renaissance Florence**

By SAMUEL KLINE COHN, JR.

FROM THE INTRODUCTION: This work investigates the side of Renaissance history which pertained to the mass of men and women and which the current historiography concludes in effect has no history—no history in the sense that the collective and individual actions of these men and women in any way helped to shape their own lives or society as a whole. To reconstruct that other side of the Renaissance in Florence, this book examines sources that never before have been studied systematically—the notarial and criminal archives of Florence. Yet this work is more than just an empirical dusting of certain shelves in the Archivio di Stato, Firenze. It considers the laboring classes in the larger

context of class relations and concludes that to understand the broad political and social changes from the fourteenth through the fifteenth centuries in Florence, the historian must consider changes both within the laboring classes (the *popolo minuto*) as well as the interaction between the laboring classes and the ruling elite—or, to be more direct, class struggle.




