THE CONTRIBUTORS

LEICESTER WEBB is Chairman of the Department of Political Science at the Australian National University in Canberra. From 1945 to 1951 he was Director of Economic Stabilization in New Zealand. In 1946 he was a member of the New Zealand delegation to the ITO Conference in Geneva and head of the New Zealand delegation to the Sterling Area Conference in London. He served as economic adviser to the New Zealand delegation to the British Commonwealth Prime Ministers' Conference in 1948. His publications include *Government in New Zealand* (1940), and he is at present working on a study of the welfare state in New Zealand.

ERNST B. HAAS is Assistant Professor of Political Science at the University of California. He is preparing, with Allan S. Whiting, an international relations textbook in which international affairs are analyzed in terms of the motivations of key socio-economic groups.

PHILIP RIEFF is an instructor in the Department of Social Relations at Brandeis University, and taught previously at the University of Chicago. He has just completed a book on *The Social Thought of Sigmund Freud*.

MORTON H. COWDEN is a candidate for a doctor's degree in the Department of Public Law and Government at Columbia University, and a Fellow in the Department of Government at the City College of New York. He is now writing his doctoral dissertation.

W. W. ROSTOW is Associate Professor of Economic History at Massachusetts Institute of Technology. He has been Harmsworth Professor of American History at Oxford, Pitt Professor at Cambridge, and served on the Economic Commission for Europe at Geneva. Among his most recent publications are *The Process of Economic Growth* (1952) and an article in the previous issue of *World Politics*.

MARION J. LEVY, JR., is Associate Professor of Sociology in the Department of Economics and Social Institutions at Princeton University. The author of *The Family Revolution in Modern China* (1949) and *The Structure of Society* (1952), he is now engaged in a comparative analysis of the social structures of China and Japan, with a view to understanding the problems of modernization in so-called underdeveloped areas.

ALBERT KERVYN is a member of the Center for International Studies at Massachusetts Institute of Technology. He worked for a number of years with the Economic Commission for Europe in Geneva and contributed to the Commission's publications.
