
As from October 1, 1987 manuscripts should be sent to the new Editor at the above address.

INFORMATION FOR AUTHORS

1. Short articles on the behavioural approach and related issues are welcome. Behavioural intervention in clinical, educational, community, or organizational settings, is of interest. Single case investigations entailing empirical evaluations are welcome.
2. Articles can be submitted to the Editor: Dr Neville King, Department of Psychology, Phillip Institute of Technology, Bundoora, Victoria 3083. (Ph. (03) 468 2200). Please forward 3 copies. The contact person regarding the manuscript should be clearly named, along with mailing address and phone number.
3. Authors should ensure that their manuscript has a cover page with title of the article, author(s), and affiliation. To facilitate anonymous review the title of the article should be given on the next page.
4. Articles should be accompanied by an abstract of about 200 words. The abstract should follow the title page on a separate page.
5. Manuscripts should be typed on A4 paper, double-spaced, with 4 cm wide margins.
6. Style should conform to the *Publication Manual of American Psychological Association* Third Edition, 1983. Footnotes are not permissible. Words should only be underlined when it is intended that they be typeset in *italics*. Page numbers should be given when quoting authors.
7. When the research format allows, authors should organize their article in terms of an introduction, method, results, discussion and references.
8. A limited number (2) of tables and figures can be included. Precise headings must be given, along with an indication as to where the table/figure should be located.
9. References in the text should contain all authors on the first citation. On subsequent citations three or more authors may be abbreviated to the first author et al. References should be listed in alphabetical order on a separate sheet(s) at the end of the article. For journal references: author's name and initials, year, title of the article, title of the journal, volume number, inclusive page numbers. References to books should include the author's name followed by initials, year, title of the book, city of publisher and publisher. Note that the year of publication is placed in parentheses immediately after the author's name in the reference list.
10. Galley proofs will be sent to the first-named author for correction. Excessive alteration, as distinct from correction of errors in reproduction, will be charged to the author.
11. Authors are presented with 25 tear-sheet or reprint copies of each article free. Additional reprints are supplied at the author's expense; orders should be placed when proofs are returned.
12. The content of papers will be subject to scrutiny by the editor and his advisers, but responsibility for the content rests with the author and not the editor or publisher. The author must agree that the same, or substantially the same, manuscript will not be published elsewhere without the consent of the editor.
