Mark R. Beissinger is Professor of Politics at Princeton University. Among other works, he is author of *Nationalist Mobilization and the Collapse of the Soviet State* (2002) and co-editor (with Crawford Young) of *Beyond State Crisis? Postcolonial Africa and Post-Soviet Eurasia Compared* (2002).

John Connelly is Associate Professor of History at the University of California at Berkeley, author of *Captive University: The Sovietization of East German, Czech and Polish Higher Education* (2000) and co-editor (with Michael Gruettner) of *Universities Under Dictatorship* (2006). He is presently finishing a book on Catholicism, race and the Jewish question, 1933–65.

Jeffrey Kopstein is Professor of Political Science and Director of the Centre for European, Russian, and Eurasian Studies at the University of Toronto. He is the author of *The Politics of Economic Decline in East Germany, 1945–1989* (1997) and is completing a study of pogroms in German-occupied eastern Europe.

Charles S. Maier is the Leverett Saltonstall Professor of History at Harvard University. He is the author most recently of *Dissolution: The Crisis of Communism and the End of East Germany* (1997), *Among Empires: American Ascendancy and its Predecessors* (2006), and forthcoming essays on ‘The Cold War and the World Economy’ and ‘“Malaise”: The Crisis of Capitalism in the 1970s’. He is working on a long-term study tentatively entitled ‘Once within Borders: History and Territory 1500–2000’.

Andrew A. Michta is Professor of National Security Studies at the George C. Marshall European Center for Security Studies in Germany. He is also the Mertie W. Buckman Distinguished Professor of International Studies at Rhodes College in Tennessee (on leave 2005–9). He has published books, book chapters and articles on US and European security, NATO, transatlantic relations, civil–military relations and democratisation. He is a member of the International Institute for Strategic Studies in London and an associate of the Institute of European, Russian, and Eurasian Studies at the George Washington University.

Silvio Pons is Professor of East European History at the University of Rome ‘Tor Vergata’. He is the author of *Stalin and the Inevitable War* (2002) and of several essays on

the history of Soviet foreign policy and international communism. He has recently edited (with Robert Service) the *Dizionario del Comunismo* (2006–7).

Marci Shore is an assistant professor of history at Yale University. She is the author of *Caviar and Ashes: A Warsaw Generation's Life and Death in Marxism, 1918–1968* and articles on Jewish, gender and literary history, and the translator of Michał Głowiński's Holocaust memoir *The Black Seasons* (2005).

Vladimir Tismaneanu is Professor of Politics at the University of Maryland (College Park). He is president of the Presidential Commission for the Analysis of the Communist Dictatorship in Romania, and author of *Reinventing Politics: Eastern Europe from Stalin to Havel* (1992, paperback with a new epilogue, 1993), *Fantasies of Salvation: Nationalism, Democracy, and Myth in Post-communist Europe* (1998), *Stalinism for All Seasons: A Political History of Romanian Communism* (2003). He edited *The Revolutions of 1989* (1999) and the forthcoming volume *Stalinism Revisited: The Establishment of Communist Regimes in Eastern Europe* (2009). During the 2008–9 academic year he was a Fellow at the Woodrow Wilson International Center for Scholars in Washington, DC, working on a book on democracy, memory and moral justice.

Amir Weiner is Associate Professor of History and Co-director of the Center for European Studies at Stanford University. His publications include *Making Sense of War: The Second World War and the Fate of the Bolshevik Revolution* (2001) and *Landscaping the Human Garden* (2003). He is currently completing a book, *Wild West, Window to the West: Sovereignty, Governance, and Revolution between the Baltic and Black Seas, 1935 to Present*.







## NOTES FOR CONTRIBUTORS

*Contemporary European History* covers the history of eastern and western Europe, including the United Kingdom, from 1918 to the present. By combining a wide geographical compass with a relatively short time span, the journal achieves both range and depth. It is open to all forms of historical enquiry – including cultural, economic, international, political and social approaches – and welcomes comparative and transnational analysis.

### Submissions

Articles submitted for publication should be sent electronically to *Contemporary European History*, at [ceh@sheffield.ac.uk](mailto:ceh@sheffield.ac.uk), or, in the case of submissions from North America, to the Corresponding Editor for North America, Professor John Connelly, [jfconnel@berkeley.edu](mailto:jfconnel@berkeley.edu).

Articles should normally be about 8,000 words long, the total to include footnotes. Review articles should not exceed 5,000 words.

The journal is published in English, and contributions are normally submitted in that language; however, we will also consider articles submitted in other major European languages. If accepted for publication, these will be translated. All articles, including those commissioned, will be refereed.

An abstract of each article is published in English, French and German.

Submission of a paper will be taken to imply that it is unpublished and is not being considered for publication elsewhere. On acceptance of a paper, the author will be asked to assign copyright (on certain conditions) to Cambridge University Press. An article cannot be published unless a signed copyright form is returned promptly.

Contributors are responsible for obtaining permission to reproduce any material in which they do not hold copyright and for ensuring that the appropriate acknowledgements are included in their text.

The editors would be grateful if contributors kept closely to the journal's stylistic conventions. Copy-editing is time-consuming and the editors will return any contribution which does not follow the conventions for correction and re-typing.

Contributors of accepted papers should send a final version via email. This should include

1. the text, which should begin with the title, the author's name and email and postal address, and the author's affiliation as he/she should wish it to appear
2. a 100-word summary of the article in English, French or German
3. a short title for use as a running page-head
4. a statement of the article's length in number of words (including both text and footnotes), and a list of tables, graphs, maps and any other illustrative material (each of which should be supplied as a separate file)
5. a short description of work in progress and previously published work
