### 2 Space, Time and Resurrection

T. F. TORRANCE

This work deals with the Resurrection in relation to space and time, with special relation to time. It attempts to set out the biblical approach to the Resurrection, in terms of the intrinsic significance of the resurrected one; and shows that the Resurrection is entirely consistent with who Jesus was and what He did, and is continuous with His whole reality.

All this is elucidated in the context of modern scientific thought and questioning, in such a way as to show that far from being frightened into a miserable compromise of the New Testament message of the Resurrection of Jesus Christ in body, it actually allows us to take its full measure. The implications of this are drawn out for eschatology and the renewal of the creation.

*The Man in the Manse* is essentially readable, it is laced with relevant, contemporary humour and anecdote and it succeeds in being both informative and entertaining. It tells of the life and work of the Scottish minister in the nineteenth century. As preacher and pastor, as local dignitary and confidant, as scholar and not infrequently as businessman and as husband and head of often a large family his day-to-day life is mapped out from material drawn from a host of diverse original sources.

The whole is set against the background of a century when the Church in Scotland was far from peaceful. The fierce struggle between the Moderates and the Evangelicals, the Disruption, the Revivals and the Heresy Cases, the distinctive problems posed by the rapid growth of the industrialised cities and the first faltering steps towards Scottish Church Reunion, all conspired to keep the Church and its doings in the forefront of the public eye.

Three times in Ronnie Falconer's life, the sighting of the Southern Cross was memorable. On S.S. "Baradine" lumbering up the African coast, the stars seemed to spell the end of happiness to a rebellious sixteen-year-old. Thirty-five years later, in Nairobi, and by now a world figure in Religious Broadcasting, he saw them again and realised how fully God had been planning his life. The third sighting was back in the New Zealand of his youth when disillusionment confirmed his faith.

This book tells what happened before and between the sightings—N.Z. youth in pioneer days; care-free student life "Under the Crown" of Aberdeen's King's College; the social conviction of the Hungry Thirties which led him to an Iron Works parish in war-time; twenty-six years in charge of BBC-Scotland's Religious Broadcasting.

The Golden Years of Radio fade into the beginnings of Television fully colourized before he retired. Great events and personalities appear in these pages. # THE CHURCH BEFORE THE COVENANTS

The Church of Scotland

1596-1638

*Walter Roland Foster*

A fresh assessment of the national Church of Scotland in the early seventeenth century, a crucial period in its history when the reformed Kirk was not only completely united but, equally important, thoroughly presbyterian and fully episcopal. Considerable progress was made in the spread of presbyteries, the establishment of reformed parishes, the growth of schools, and the financial reorganization of the Church. A pragmatic solution as much as a doctrinaire one, the Scottish Church was a unique Reformation experiment.

Rather than rely solely upon the polemical histories written at the time, Professor Foster has drawn on primary sources – presbytery minutes, synod records, journals, letters and wills – and thus achieves a closer understanding of the ordinary operation of the Church, which is revealed as both effective and harmonious, and not beset by intense rivalry or factions.

Apart from its historical importance, Professor Foster's study has clear implications for re-union plans which seek to embrace both the reformed and episcopal traditions.

### REVELATION AND THEOLOGY

An analysis of the Barth-Harnack correspondence of 1923

H. MARTIN RUMSCHEIDT

In 1923 Adolf von Harnack, the Professor of Church History at Berlin, and his former pupil Karl Barth published in the Journal *Christliche Welt* an exchange of five open letters. This correspondence represents a classic statement of the two sides in a continuing theological debate about the nature of the theologian's expertise and his understanding of God. Harnack defended the established academic ideal of a 'scientific theology'—an objective study consisting primarily of historical investigation and critical reflection. Barth emphasized instead the role of revelation, grace and personal commitment in our understanding of God, arguing that to rely on the external proofs and authorities of natural theology was to empty religion of its significance and reality for the individual.

Dr Rumscheidt presents the correspondence, in translation, with a full critical analysis and evaluation. He estimates the importance of this debate for the new theology and the new Reformation which Barth can be said to have inaugurated.

### DAVID FRIEDRICH STRAUSS AND HIS THEOLOGY

HORTON HARRIS

A study of David Friedrich Strauss, certainly the most notorious and arguably the most important theological figure of the 19th century. His *Life of Jesus* (1835), repudiating the historicity of the Gospels, split the century into two theological eras and set in motion the 'Quest for the historical Jesus' and the ensuing investigation into the authenticity of the N.T. writings. His view that the Gospels were quite untrustworthy as historical sources threatened to undermine the whole foundation of the Christian Church and thus provoked a strong counter-reaction from inside the establishment. Strauss rejected the supernatural and rationalistic interpretations of the Gospel miracles and championed a third view—the mythical interpretation: the Gospel stories were myths, unconsciously invented to fulfil the messianic prophecies in the O.T. The mythical interpretation thus brought into sharp focus for the first time the relationship between New Testament history, philosophy and faith.

### INDIA AND THE LATIN CAPTIVITY OF THE CHURCH

The Cultural Context of the Gospel

ROBIN H. S. BOYD

Dr Boyd writes from the practical situation of an Irish missionary in India. He studies the development of a genuinely *Indian* Christian theology, detached from its traditional 'Latin' encasement (hence the title) and expressed in a form appropriate to Indian culture and Indian modes of thought.

The Christian Church is now strongly established in India and has evolved its own activities and structures, quite distinctive from those of the Church in the West. Dr Boyd suggests that the western Church can in turn learn from the eastern, and must do so if it is to liberate its theological language, its organisational structures and its 'colonial' approach to the spread of Christianity from the traditional forms which now impede it. In this way the Christian faith and the true Christian message—in both East and West—can be more clearly defined and experienced.

THE DOCTRINE OF THE TRINITY

God's Being is in Becoming

EBERHARD JÜNGEL

The theme of this startling book is the *Being* of God, re-considered in the light of Karl Barth's epoch-making work on the Trinity which made it the fundamental grammar of Christian theology affecting every aspect of doctrinal thought. In a sharp critical handling of classical and contemporary ideas Jüngel breaks through static conceptions of God to develop a radically dynamic understanding of the Being of God as *Becoming*, but this involves also a rethinking of the meaning of *becoming* itself. Short as it is, Professor Jungel's work is the most penetrating and brilliant piece of theological writing on the doctrine of God to appear for a long time. Far from being a theological imposition upon the self-revelation of God in the crucified and risen Jesus Christ, this is an account of the living Being of God that arises out of the concrete realities of the passion of Christ regarded as the passion of God. The crucifixion thus emerges as the crucial point in a proper and compelling doctrine of the Trinity, while the incarnation of the second Person of the Trinity is at the same time cast in a new light. The book has much to offer the New Testament scholar as well as those who are interested in contemporary theological debate. Altogether it is a work of great daring and profound insight. It is hardly surprising that Professor Jüngel's classrooms in Tübingen overflow with many hundreds of students.

*The Origin of Science  
and the Science of its Origin*

STANLEY L. JAKI

Modern man owes an immense debt to science. He has received on the one hand the practical benefit of powerful tools and on the other the stimulus to his imagination through the unveiling of the remote past. Yet science is a recent phenomenon. Its three-hundred-year-old history has occupied but a few moments of recorded time. No wonder that its novelty has provoked not a few reflections.

These reflections on the recent origin of science are the materials and rudiments of the science of its origin. For the first time they are surveyed and analysed in this book, the text of five lectures delivered at Balliol College, Oxford in 1977.

The historical survey is given in the first four lectures which deal in succession with the material accrued during the seventeenth, eighteenth, nineteenth, and twentieth centuries. The lesson provided by this historical material and the analysis of that lesson, given in the fifth lecture, are the support of this book's major claim: only a Christian outlook can provide that view in depth of the origin of science which is needed for a proper appraisal of the past of science, and of its future impact.

Stanley L. Jaki, a Hungarian-born Benedictine priest, is Distinguished Professor at Seton Hall University, South Orange, N.J., who has been internationally acclaimed for his books on the history of physics and cosmology. In 1975 and 1976 he was Gifford Lecturer at the University of Edinburgh and has lectured widely in the United States and Europe. He was the recipient of the Lecomte du Nouy Prize for 1970.

Submission of an article is taken to imply that it has not previously been published in English, or is not being considered by another journal for publication in English. In the interests of authors, copyright is normally assigned to the Scottish Academic Press. The average length of articles is 5000 words. Although longer articles are accepted, those in excess of 10,000 words cannot be considered.

Contributions (articles and reviews) should be clearly typed in double spacing, and on one side of the paper only. The rule about double spacing applies also to footnotes, which should be used sparingly. Cross-references within the article offered should not be included.

Notes for the editors and instructions for the printer should be attached on separate sheets. Contributors should keep one copy of the typescript for use in correcting proofs.

Contributors from the United States may use U.S. spellings. Greek and Hebrew words need not be transliterated. Capitalisation should be kept to a minimum; and in particular should not be used in pronouns referring to the Deity.

First proofs of articles and reviews may be read and corrected by contributors, and should normally be returned to the organising editor within ten days of receipt. Correction should be confined to errors of the printer. More extensive correction can be made only with the concurrence of an editor. No proofs of reviews will be sent.

Contributors of articles and article reviews (but not of reviews) receive 10 free offprints. Extra copies may be bought according to an agreed scale of charges, provided that these are ordered at the time of returning corrected proofs.
