CALL FOR PAPERS: Agricultural and Resource Economics Review (ARER)

THEME: Agricultural, Resource, and Environmental Policies in the 1990s

The *Agricultural and Resource Economics Review* (formerly the *Northeastern Journal of Agricultural and Resource Economics*) will publish papers on the theme "Agricultural, Resource, and Environmental Policies in the 1990s" as a special section of its Spring 1994 issue. In the papers, author(s) are expected to review and discuss current knowledge, issues, research needs, and appropriate research methods. Papers will be subject to blind-review. There will be page charges on published articles.

Author(s) might address procedures and methods used to determine the impact of agricultural, resource, and environmental policies on various segments of the economy. The political economy of formulating these policies might also be addressed. Assessment of the impacts of the 1990 Farm Bill and the debate on the preparation of the 1995 Farm Bill are also of interest.

Other possible topics include the interaction between environmental and international trade policies, the implications of making farm subsidies contingent on environmental performance, and the effects of agricultural, resource and environmental policies in promoting alternative technologies/products (e.g., sustainable agriculture, biotechnology).

Theoretical and empirical work are welcome.
