

Information for contributors



General information: submission of manuscripts

The *International Review of the Red Cross* invites submission of articles on subjects relating to international humanitarian law, humanitarian policy or humanitarian action, provided the article has not been published, submitted or accepted elsewhere. Articles are peer-reviewed prior a decision being taken about their acceptability for publication. The decision whether or not to publish an article is made by the Editor. The *Review* reserves the right to edit articles. Notification of acceptance, rejection or the need for revision will be given within four weeks of receipt of the manuscript. In any case, manuscripts will not be returned to authors.

Manuscript requirements

CONTENT: The manuscript should contain a title page with the name(s) of the author(s) and short biographical statement(s) (maximum 40 words); a summary; the main text; tables and figures (if any), and notes and references.

LANGUAGE: Manuscripts should be submitted in either English or French. Texts are published in the original version together with a summary in the other language.

LENGTH: Articles should be within 10 to 30 double-spaced printed pages (3,000 to 12,000 words). Authors are kindly requested to provide a summary, comprising 100 to 200 words.

SUBHEADINGS: Articles can include only 2 levels of subheadings. The first should be in bold, the second in italics.

NOTES AND REFERENCES: These should be in the form of footnotes. Authors should follow the *Review's* Guidelines for Referencing and Footnotes available on the ICRC website. Manuscripts that do not fulfill the above requirements will not be considered for publication.
