CONTRIBUTORS

Eline van Ommen is a Lecturer in Contemporary History at the University of Leeds. She previously taught at Utrecht University and obtained her PhD in International History at the London School of Economics and Political Science in 2020. Her specialities include the Cold War in Central America, transnational activism, and revolutionary diplomacy. She is completing a monograph on the international and transnational history of the Nicaraguan Revolution (1979–90), which draws on archives and oral history interviews in Nicaragua, Cuba, the United States, the Netherlands, Germany, and the United Kingdom.

Tanya Harmer is Associate Professor of International History at the London School of Economics. She has published widely on histories of the Cold War in Latin America, with particular focus on Chile, Cuba, US-Latin American relations, revolution, gender, and exile. She is the author of *Allende's Chile and the Inter-American Cold War* (University of North Carolina Press, 2011), which won the Latin American Studies Association's Luciano Tomassini Prize. Her latest book is *Beatriz Allende: A Revolutionary Life in Cold War Latin America* (University of North Carolina Press, 2020). She has also co-edited two volumes on revolution and the Cold War in Latin America: *Chile y la guerra fría global* (Revista Iberoamericana de Lingüística, 2014, with Alfredo Riquelme Segovia) and *Toward a Global History of Latin America's Revolutionary Left* (University Press of Florida, 2021, with Alberto Martín Álvarez).

Mateo Jarquín is Assistant Professor of History at Chapman University. His scholarship asks how twentieth-century revolutions in the so-called Third World have framed global debates about development, democratization, and international relations. Based on archival and oral history research in several Latin American countries, his current book project examines the rise and fall of Nicaragua's Sandinista Revolution (1979–90) through a hemispheric and transnational lens.

Molly Avery is a PhD candidate in the Department of International History at the London School of Economics. She is a historian of the Latin American Extreme Right, and her dissertation tells a transnational and international history of Chilean and Argentine involvement in the conflicts in Guatemala and

El Salvador in the late 1970s and early 1980s. Her work can also be found in the *Journal of Latin American Studies*.

Emily Snyder is the Mellon Fellow of American History at Cambridge University. She earned her PhD from Yale University in 2021, and her dissertation, “Entangled Revolutions: Cuba, Nicaragua, and the United States in the Cold War Caribbean, 1979–1990,” won the George Washington Egelston Prize from Yale and the Edwin W. Small Prize from Yale’s Department of History. Her work can also be found in *Cuban Studies* and the *Radical History Review*.
