## SPECIAL ANNOUNCEMENT

THE LATIN AMERICAN STUDIES ASSOCIATION (LASA) OFFICIALLY CAME INTO EXISTENCE on May 7, 1966 at a meeting held in Washington, D.C. which was attended by more than seventy Latin American scholars and representatives of institutions with major commitments in Latin American research.

In the two-day meeting, hosted by the Hispanic Foundation and sponsored by the Joint Council of the SSRC-ACLS, the articles of Constitution were discussed and ratified and the board of directors was elected.

LASA was incorporated officially on May 12, 1966.

A subsequent meeting of the newly elected Executive Council ratified the By-Laws.

## **BOLETIN INFORMATIVO SOBRE ESTUDIOS LATINOAMERICANOS EN EUROPA**

La iniciativa para la publicación de este boletín fue tomada en la conferencia "Europa-América Latina" que tuvo lugar en Bellagio (Itália) del 4 al 9 de octubre de 1964, durante la cual el recién establecido "Centro de Estudios y Documentación Latinoamericanos de la Universidad de Amsterdam" aceptó la invitación de actuar como "clearing house" para los centros e institutos europeos dedicados a los estudios latino americanos en el campo de las ciencias sociales en el sentido más amplio de este término y publicar un boletín semi-anual con información sobre investigaciones en progreso, datos sobre programas de estudios latinoamericanos en Europa, así como noticias sobre intercambios de profesores y estudiantes entre la América Latina y Europa.

El primer número del *Boletín Informativo* fue publicado en el mes de abril de 1965 y ha tenido muy favorable acogida. El segundo número fue publicado a fines del mes de noviembre. Los primeros números serán gratis.

El boletín es publicado en idioma castellano y distribuido en América Latina, América del Norte y en Europa para servir como una fuente de actualidades que dará valiosas informaciones a las personas e institutos interesados sobre las actividades en Europa con respecto a los estudios latinoamericanos.
