Despite its immediate popularity, Ariosto's *Orlando Furioso* (published in its final version in 1532) was for learned readers a perplexing work: it mixed romance, epic, and lyric poetry, poked fun at its marvelous and outmoded chivalric matter, contained many interrupted narrative threads, and included base and lowborn characters. In exploring the literary debates involved in elevating the *Furioso* to the rank of a classic, Daniel Javitch maintains that this was the first work of modern poetry to provoke widespread critical controversy, and that the contestation played an inaugural role in the formation of the European poetic canon.

In this lavishly illustrated history of the place of the garden in Roman life, David Coffin first considers the role of cloistered gardens in the Middle Ages and shows how they were later incorporated as private spaces within the larger Renaissance gardens. Describing the introduction of sculptural collections and waterworks into gardens during the sixteenth century, he explores some of the rich, often complicated, iconographical programs that emerged. Finally, he demonstrates that the extension of garden parks in the seventeenth century marks the diminishment of architecture in landscaping and the advent of landscape design as a dominant factor.


