

This book aims to offer a (not *the*) Chinese perspective on some of the issues to be decided by the Tribunal and thus to assist the Tribunal in meeting its obligations under the Convention. The book does not set out the official position of the Chinese government, but is rather to serve as a kind of *amicus curiae* brief advancing possible legal arguments on behalf of the absent respondent.

Global Order Beyond Law

How Information and Communication Technologies Facilitate Relational Contracting in International Trade

Thomas Dietz

The aim of this work is to shed light on the governance of complex cross-border contracts by developing a comprehensive theoretical framework for understanding the relevance of both formal and informal institutions. This framework is then applied to an empirical study of cross-border software development contracts. Combining a unique data set of 41 qualitative expert interviews with statistical data and surveys, the author demonstrates that state contract laws show fundamental signs of dysfunction across borders.
