





## The Politics of Peace

An Evaluation of Arms Control

*John H. Barton.* As practiced in the last two decades, arms control can provide some, but only very limited, help in maintaining peace; this is the conclusion that emerges from this evaluation of the capabilities and limitations of arms control. Substantial reductions in weapons are extremely desirable, but the author suggests that the current arms control approach is politically unable to produce such reductions, as confirmed by the SALT negotiations and the withdrawal of the draft SALT II treaty. After reaching this pessimistic judgment, the author considers possible changes in the arms control process. The resulting new arms control agenda includes international organization reform, new kinds of expert groups, and new forms of international military consultation. For all these innovations he suggests politically plausible first steps. \$18.50

The World Peace Foundation, a small, innovative operating foundation widely known since 1910 for the substantive quality and policy relevance of its programs on a broad spectrum of international issues, seeks a chief executive officer. The new Director will work with an active board of trustees internationally recognized in their respective fields to plan and implement programs of research, conferences, and publication. The Foundation's substantive priorities change as international issues develop and it can bring special expertise to bear upon them. Over the past decade or so the Foundation's work has focussed on such issues as the proliferation of nuclear weapons, U.S.-Canadian relations (with continuing attention to the special situation of Quebec), southern Africa, international migration, the Middle East and the Maghreb, transnational and transgovernmental relations, and international energy problems. The Foundation also sponsors publication of the quarterly *International Organization*.

To fill the directorship the Foundation seeks a person of imagination and sound analytical judgement regarding international affairs. Most important will be an ability to work effectively to translate proposals into programs, and to interact well with outside specialists of diverse nationality and expertise. Although he or she might be employed on a less than full-time basis, his or her commitment must be substantially more than half time. Compensation will be negotiable. The new Director should begin work no later than September 7, 1982.
