Coffee and Conflict in Colombia, 1886–1910

Charles W. Bergquist

with a new prologue by David Bushnell

The publication of Bergquist's *Coffee and Conflict* in 1978 had several important results in the field. It provided a major contribution to Colombian historiography in its examination of the growth of the coffee industry and the Thousand Days War; in addition, by its analysis of this transitional period in terms of what has been called the dependency theory, the work has left its mark on all subsequent studies in Latin American affairs. Questions of economic development and political alignments cannot be dealt with properly without confronting Bergquist.
