

## Guide for Contributors and Referees

On-line submission is welcomed of original articles which have not been published elsewhere and are not under consideration for publication elsewhere. The journal accepts scholarly/research-based Articles (normally of 8,000 words or fewer), Review Articles discussing a number of significant recent publications in context (normally of 6,000 words or fewer), and shorter Book Reviews and Comments.

### How to submit

#### Submission title page

Please provide a title page as a separate file. It should contain:

1. Title of submission
2. Type of submission
3. Names and institutional affiliations of all authors in the order desired
4. A two-sentence statement about each author
5. Email address/es for correspondence

#### Manuscript

Please ensure that the manuscript is in Word format, and:

1. Does not contain authors' names
2. Contains the title
3. Contains an abstract of no more than 150 words
4. Lists up to 10 keywords
5. If relevant, lists JEL codes (see the ELRR's website for more info)
6. Contains in-text indications of where any tables and graphs should be located.

#### Referencing

A references list should be included at the end of the text. This should cite all works referred to. The reference list should be arranged in alphabetical order by author. You are recommended to use a bibliographic program like EndNote. Use of the formats set out below will prevent publication delays.

### Copyright and publication permissions

Copyright of articles published in ELRR is vested in the journal. Permission to reprint should be sought from the Editors. This will be granted in normal circumstances. All submissions must be accompanied by a completed copyright assignment form, available from the ELRR's website <http://www.asb.unsw.edu.au/research/publications>

#### Formatting

1. If you use acronyms and abbreviations, use the full title the first time, followed by the acronym in brackets
2. Mathematical notation should be provided in both symbols and words. Articles of a mathematical nature should also contain a clear statement of the arguments in plain English, with substantial amounts of mathematical material placed in an appendix
3. Quotations of four or more lines should be indented. Shorter quotes should be placed in the body of the text
4. Endnotes, which should be kept to a minimum, should be numbered serially and included at the end of the article
5. Tables, graphs and charts: Please provide Excel files of these in case reformatting is needed for legibility. Please note: All tables, charts and graphs should be clearly titled and numbered consecutively and included at the end of the text. Titles should be outside the borders of charts or graphs.
