

RETROSPECTIVE ON THE END OF THE COLD WAR

Report of a Conference Sponsored by the John Foster Dulles Program
for the Study of Leadership in International Affairs

In February 1993 the John Foster Dulles Program for the Study of Leadership in International Affairs of the Woodrow Wilson School convened a unique assemblage of American and Soviet actors who had participated in the international diplomacy that spelled the end of the cold war. During the two and a half days of the conference they reviewed and reflected on the events of the latter half of the 1980s and on their own experiences. Topics discussed included arms buildups and reductions, crisis flash points, Afghanistan, the Reykjavik summit, and the leadership qualities of Presidents Ronald Reagan and Mikhail Gorbachev. The monograph presents extensive excerpts from the transcript of the conference, which contains numerous insights not only into the specific events of the period but also into the more general dynamics of conflict resolution. The full transcript will be published by Johns Hopkins University Press in a forthcoming book edited by William C. Wohlforth.

The participants and their official positions at the time of the events discussed were Alexandr A. Bessmertnykh, former Soviet foreign minister and ambassador to the United States; Frank R. Carlucci III, national security adviser to President Reagan and secretary of defense; Anatoly Chernyaev, personal adviser on foreign affairs to President Gorbachev; Jack F. Matlock, Jr., director of Soviet affairs on the National Security Council staff and ambassador to the Soviet Union; Paul H. Nitze, ambassador-at-large and special adviser to President Reagan and Secretary Shultz on arms control; Pavel Palazchenko, special assistant and interpreter to Mikhail Gorbachev; Rozanne L. Ridgway, assistant secretary of state for European and Canadian affairs; George P. Shultz, secretary of state; and Sergei Tarasenko, principal policy assistant to foreign minister Eduard Shevardnadze.



ECONOMIC POWER IN INTERNATIONAL RELATIONS

By SAMUEL P. HUNTINGTON

This essay inaugurates a new monograph series, published under the auspices of the Research Program in International Security at Princeton University's Center of International Studies.

Professor Huntington argues that, because many Americans tend to be concerned primarily with improving national economic *welfare*, they have overlooked the importance of economic *power* in the relations between nation-states. Comparing postwar Japanese economic policies with those of the United States, Huntington maintains that Japan has pursued a deliberate strategy of maximizing its national economic power, while the United States has generally been content to achieve steady gains in the absolute level of well-being of its citizens. If it wishes to preserve its primacy in the international system, the author concludes, the United States will have to be far more purposeful in its pursuit of economic power.




In this work Beth Simmons presents a fresh view of why governments decided to abide by or defect from the gold standard during the 1920s and 1930s. Simmons, on the other hand, analyzes the influence of domestic politics on national responses to the international economy.
