## Inventing the "Great Awakening"

Frank Lambert

This book is a history of an astounding transatlantic phenomenon, a popular evangelical revival known in America as the first Great Awakening (1735-1745). Frank Lambert offers an overview of this important episode and proposes a new explanation of its origins. He finds that the Great Awakening was invented—not by historians but by eighteenth-century evangelicals who were enthusiastic religious promoters. By examining the texts that these preachers skillfully put together, Lambert shows how they told and retold their revival account to themselves, their followers, and their opponents.




