# Witchcraft in France and Switzerland

*The Borderlands during the Reformation*

**By E. WILLIAM MONTER.** Firmly based on rich and remarkably well preserved documentary sources, this book traces the rise and decline of witch-hunting along the French-Swiss frontier in the era of the Reformation. Mr. Monter characterizes the "Jura region," where different styles of witchcraft mingled, as "an excellent laboratory in which to test and compare ideas about the history of European witchcraft." After describing the intellectual climate that gave rise to witch-hunting, he reviews witchcraft trials in terms of severity of persecution, the role of women, and the effects of religious differences. He contrasts popular beliefs with official views on such topics as werewolves and curses, and compares the pattern of persecution in the Jura to patterns elsewhere in Europe. \$15.00
