THE CONTRIBUTORS

BERNARD BRODIE is a Senior Staff Member of the RAND Corporation. He is the author of *Sea Power in the Machine Age* (1941), *A Guide to Naval Strategy* (3rd ed., 1944), and co-author of *The Absolute Weapon: Atomic Power and World Order* (1946).

RICHARD PIPES is Research Associate at the Russian Research Center and Tutor in History and Literature at Harvard University. His study, *The Formation of the Soviet Union: Communism and Nationalism, 1917-1923*, appeared in 1954, and he is now working on a history of Russian Conservatism.

WILLIAM T. R. FOX is Professor of International Relations and Director of the Institute of War and Peace Studies at Columbia University. The author of *The Super-Powers* (1944), Professor Fox is a member of the editorial board of *World Politics*.

FRANZ MICHAEL is Professor of Chinese History and Assistant Director of the Far Eastern and Russian Institute at the University of Washington. He has published *The Origin of Manchu Rule in China* (1942), and is preparing a book on the modern history of the Far East with George Taylor, as well as one entitled *Regional Forces and the Decline of China's Last Dynastic Government*.

ALEXANDER ECKSTEIN, Research Associate at the Russian Research Center, Harvard University, was formerly an economist in the Division of Research for the Far East in the State Department. Co-author, with W. W. Rostow, of *Prospects for Communist China* (1954), he is working on a monograph on the national product of mainland China.

EVERETT E. HAGEN is a member of the Center for International Studies and Acting Professor in the Department of Economics at M.I.T. A contributor to the forthcoming *World Trends and Living Standards* (presenting the lectures at the 1954 Norman Wait Harris Foundation conference at the University of Chicago), he is making a study of economic development in Burma.

RICHARD C. SNYDER is Associate Professor of Politics and Director of the Foreign Policy Analysis Project at Princeton University. He serves as consulting editor of the Doubleday Studies in Political Science, and is co-author, with Edgar S. Furniss, Jr., of *American Foreign Policy* (1954) and, with H. W. Bruck and Burton Sapin, of *Decision-making as an Approach to the Study of International Politics* (1954).

ROBERT A. DAHL, Associate Professor of Political Science on the Eugene Meyer Public Service Fund, Yale University, is the author of *Congress and Foreign Policy* (1950) and, with C. E. Lindblom, of *Politics, Economics, and Welfare* (1953). He is completing a study of democratic theory, based on his Walgreen Lectures at the University of Chicago in January 1955.

ROGER HILSMAN is a staff member of the Center of International Studies, Princeton University, and is currently engaged in research on the changing role of military force in foreign affairs.

P. E. CORBETT is a member of the Center of International Studies, Princeton University, and serves on the editorial board of *World Politics*. Among his publications are *Britain: Partner for Peace* (1948) and *Law and Society in the Relations of States* (1951).
