ANTHROPOLOGY IN ADMINISTRATION

By H. G. Barnett, *Professor of Anthropology, University of Oregon. Former Staff Anthropologist, (U.S.) Trust Territory of the Pacific Islands*

Anthropology as it has been applied to problems arising in connection with the administration of non-self-governing peoples. This includes a review of previous uses of anthropology in various colonial administrations and a detailed presentation of the unusual plan put into effect in the U.S. Trust Territory of the Pacific Islands in 1951.

The book describes varied administrative approaches to the problem of getting information about native peoples; analyzes the differences of opinion between administrators and anthropologists and among anthropologists themselves on the use of social science in government; includes case material relevant to the administration of any dependent people.

Both the student of anthropology and the student of government will find this book of interest and practical value.

Written in nontechnical language. Suitable for use as a basic text in courses in applied anthropology and as collateral reading for courses in colonial government. Has practical value for the government official and social planner.
