## Foundation of Political THEORY Group

# EDGAR S. FURNISS, Jr. Award

The Mershon Center of The Ohio State University has announced an annual competition for the best book-length manuscript dealing with significant contributions of the policy sciences to national security and civilian military education.

The Award of \$1,000 and publication by the Ohio State University Press is intended to commemorate the intellectual leadership of Edgar S. Furniss, Jr. and his unique role in establishing the Mershon Center.

Manuscripts will be judged by the Mershon Center Editorial Board on the basis of relevance to the Award subject, scholarship, and clarity of exposition.

# Lewis Anthony Dexter ARCHIVE

The department of political science at the Johns Hopkins University has announced the establishment of the Lewis Anthony Dexter Archive of Elite Interviews at the Milton S. Eisenhower Library of the Johns Hopkins University. The purpose of the Archive is to collect and to maintain interview reports and protocols with persons holding important governmental, business, and other positions of leadership as well as with their staffs and other persons having special knowledge of public affairs, especially in the United States and Canada since 1950. An initial group of over 1200 interviews, such as those conducted for the study by Bauer, Pool, and Dexter, American Business and Public Policy, has been deposited in the Archive. In making this initial donation to Johns Hopkins, Lewis A. Dexter said: "These interviews in the long run may be useful because in many ways they are the nearest equivalent today to the political correspondences of the 18th and 19th century. Prominent figures seldom write anecdotes or explain motivations in letters; they use the telephone. Interviews record these and should be preserved."

The department hopes to secure other donations in order to preserve interviews with important decision-makers and to develop the Archive into a resource for the analysis of political and organizational activity and of the process of elite and specialized interviewing. People who have conducted such interviews and their heirs are invited to deposit interviews in the Archive. The confidentiality of such interviews will be strictly observed. # HADLEY CANTRIL Memorial Fund Award

Alex Inkeles and David Horton Smith have received the Hadley Cantril Memorial Award, a new award for outstanding publication in the social sciences. They are co-authors of *Becoming Modern*, published by the Harvard University Press in 1974.

The Hadley Cantril Memorial Award is presented annually to the publication judged by a seven-member Awards Committee to represent an especially significant contribution in the social and behavioral sciences.

The Award consists of a medallion bearing a likeness of the late Hadley Cantril and a citation which reads: "Presented to Alex Inkeles and David Horton Smith for their work entitled *Becoming Modern*—a valued contribution to the study of development through its insistence on the human dimension of the process of modernization, its clear relevance to public policy and its rigorous empirical foundation."

The Award was established in memory of Hadley Cantril, a pioneer in social psychology, an early student of public opinion and an adviser to Presidents Roosevelt, Eisenhower, Kennedy and Johnson on the psychological aspects of foreign policy.

Becoming Modern was selected from many works which were nominated for the 1975 Award. The selection was made by an Awards Committee of seven individuals, each accomplished in his field and collectively representing the diversity of the interests of Hadley Cantril. Awards Committee members are W. Phillips Davison, Professor of Journalism and Sociology at Columbia University; Albert H. Hastorf, former Dean of the Faculty and currently Professor of Psychology at Stanford University; William H. Ittelson, Professor of Psychology at the University of Arizona; Philip E. Jacob, Professor of Political Science at the University of Hawaii; Kenneth E. Livingston, M.D., of the Department of Neurological Surgery of the Wellesley Hospital in Toronto; Vincent P. Rock, Staff Director of the Commission on the Operation of the Senate; and Hans Toch, Professor of Psychology in the School of Criminal Justice of the State University of New York (Albany).

## POPULATION Policy Symposium Issue

The *Policy Studies Journal* has scheduled a special symposium issue for Winter 1977 on "Population Policy" to be edited by Michael Kraft, Vassar College, and Mark Schneider, SUNY, Stony Brook. #### INTERFUTURE

Sophomores and freshmen across the U.S. are now invited to undertake accredited independent study projects as InterFuture Scholars next year in Ghana, England, Holland, Ireland, and Jamaica. InterFuture is a non-profit educational organization headquartered at 535 Fifth Avenue, Suite 3103, New York City 10017.

Students selected to be InterFuture Scholars will begin this summer to plan cross-cultural investigations which will take them in 1977 to a European country for the spring semester and/ or a developing nation for the summer. Abroad, each participant will live with local students and families and carry out a study with the help of a local expert. On return, the IF Scholar presents his or her findings to campus and community audiences in the U.S.A.

Over 70 undergraduates have been InterFuture Scholars since the program was organized in Princeton seven years ago. Each student's project is accredited by his or her home college or university as part of work toward the bachelor's degree. Study projects are carried out in a wide variety of fields, including social sciences, peace studies, history, education, environmental studies, the arts, business, and public health.

Around the central theme "Intercultural Studies for the Future," IF Scholars have examined such topics as multinational corporations, women political leaders, refugees, labormanagement relations, folk art, ocean pollution, family planning, rural development, sickle cell anemia, and the black theatre.

# HANDICAPPED Americans Rights Review

The official journal of the HEW Rehabilitation Services Administration, American Rehabilitation, will have a special issue of interest to the political science community this Spring. The May-June issue will be "A Bicentennial Review of the Rights of Handicapped Americans."

Articles to be included range from an overview of the demographics of the handicapped popu-

lation to a case study of the accessability of the Washington, D.C. METRO system which brought forth some major court decisions, Other papers will describe legislative groups, tactics, and outcomes vis-a-vis handicapped people; legal advocacy, including the trends which have led to such cases as O'Connor v. Donaldson; and higher education for severely handicapped people. The latter paper, prepared by the former Director of the Physically Disabled Students Program at the University of California, Berkeley, offers insight into on campus discrimination vs. handicapped people, and strategies which can work for students, teachers, and administrators to combat such abuses.

Another aim of the special issue is to inform public policy makers, teachers and researchers of the complex issues which have arisen concerning rights of handicapped people. The editor of the special is Dr. Richard P. Melia of the Office of Human Development of the HEW Rehabilitation Services Administration. # FOREIGN SERVICE Women and Minorities Program

A new U.S. State Department program seeks to recruit women and minorities over 30 years of age for skilled jobs in the Foreign Service. The program is part of an affirmative action effort to improve the representation of women and minorities in the middle level of the Foreign Service. As of June 30, women represented only eight percent of the Foreign Service Officer corps.

Applicants must be at least 30 years of age at the time they apply and at least 31 at the time of their appointment. Appointments are made on a highly competitive basis. Among the skills in demand are economists, political scientists, foreign trade specialists, managers and administrators from government and private industry, and labor-management specialists. Starting salaries range from \$17,625 to \$27,221. Applicants should submit a completed form SF-171 (Standard Application for Federal Employment) to the Office of Equal Opportunity, Department

of State (M/EEO), Room 4427, Washington, D.C. 20520. The form is available at post offices, U.S. Employment Service offices, and Federal Government offices.


