Western Political Science Association

The Western Political Science Association at the April 8, 1971 Annual Meeting at Albuquerque, New Mexico adopted the report of a special Committee on the *Western Political Quarterly* chaired by Dean Mann, University of California, Santa Barbara. The report recommended among other proposals that the Western Political Science Association adopt as its official publication the *Western Political Quarterly*. At the Executive Council meeting of the Western Political Science Association on April 10, 1971, Donald Hanson, University of Utah, was named Editor of the *Western Political Quarterly* for a three year term, succeeding Ellsworth Weaver, retiring long-time editor, also of the University of Utah.

Subsequent to an Executive Council meeting of the Western Political Science Association on October 23, 1971 at Salt Lake City, President Currin Shields appointed for a three year term as Book Review Editor of the *Western Political Quarterly* Ross Rice, Arizona State University, succeeding Stanley Anderson, University of California, Santa Barbara.

The regular membership dues of the Western Political Science Association is now \$9 a year and includes a subscription to the *Western Political Quarterly*.

Language Problems Journal

A new interdisciplinary and multilingual journal of language problems and language planning, entitled *La Monda Lingvo-Problemo*, is being published in The Hague by Mouton, in cooperation with the Center for Research and Documentation on the Language Problem. Subscriptions at \$8.00 per year are being solicited by the publisher, and manuscripts are being sought by the editor, Dr. Victor Sadler, Nieuwe Binnenweg 176, Rotterdam-3002, Netherlands.

The politics of official and working languages in the United Nations; language disputes in Canada, Belgium, Pakistan, and other plurilingual nations; attitudes of bilingual Puerto Ricans in New York City; language problems in diplomacy; and the influence of language on science are among the

topics explored in the first few issues of the journal, and suggest the range of subjects on which manuscripts would be considered.

Participation 72 Program

The Hinckley Institute of Politics of the University of Utah which was established in 1965 to interest young Americans to participate actively in practical politics has prepared a model program, "Participation 72" to encourage the participation of young people in politics this year. The new program is based on the successful "Participation 70" program where 80 per cent of the eligible student voters at the University of Utah registered to vote and some 90 per cent actually voted.

The "Participation 72" program is based upon the idea of establishing districts and then systematically developing participation of potential young voters. Sponsored by the CUNY Ph.D. program in Political Science and the CUNY Office of Urban Policy and Programs, it is the official newsletter of the Comparative Urban Studies Committee of the American Society for Public Administration's Comparative Administration Group and the Committee for Community Research of the International Sociological Association.

Included will be bibliographic listings and brief abstracts of selected books, chapters, articles, and unpublished manuscripts (e.g., dissertations and conference papers); notes on current research, including progress reports and research inquiries; descriptions of available data sets; news of urban conferences and relevant panels at association meetings; institutional developments at urban centers and elsewhere; and special features such as review essays and methodological commentaries.

Foreign-Born Political Scientists

The Caucus of Foreign-Born Political Scientists elected a new Executive Committee at the 1971 APSA Convention in Chicago. The objectives of the Caucus continue to be: (a) to investigate and study the status of foreign-born political scientists in North America, and (b) to facilitate communications and exchange of ideas among foreign-born political scientists.
