

CONTRIBUTORS TO THIS ISSUE

Douglas Cole, Assistant Professor of History at Simon Fraser University and currently visiting at the University of Victoria, has published several articles relating to nationalism and ethnic ideas in Canada and Australia. He is presently working on a study of patterns of loyalty in British settlement colonies.

David M. Fahey, Associate Professor of History, Miami University, Oxford, Ohio, has published several articles on British historiography, and is at present writing a book about the temperance question in British politics, 1891-1908.

A. Z. Freeman is Professor of History at the College of William and Mary. He has published articles on English medieval military history in *Speculum* and the *J.B.S.* He is currently writing a book on the Scottish wars of King Edward I.

Michael A. R. Graves is a Senior Lecturer in History at the University of Auckland, New Zealand. He has published a textbook *England under the Tudors and Stuarts* and an article on the two Lords Journals of 1542 in the *Bulletin of the Institute of Historical Research*. He is at present completing his doctoral thesis on the House of Lords, 1539-71.

Glenn O. Nichols is an Assistant Professor of History at Iowa State University. This article is his first publication. He is currently working on a book about the Earl of Danby's administration of the Treasury.

B. J. Shapiro, a lecturer in the Department of History at the University of California at Berkeley, is the author of *John Wilkins 1614-72: an Intellectual Biography*, published in 1969, and of a recent article on "Latitudinarianism and Science in 17th Century England," which has appeared in *Past and Present*. She is at work at present on studies of political ideology, and law reform in Stuart and Early Hanoverian England.

Vernon F. Snow, Professor of History at the University of Nebraska, is the author of *Essex the Rebel*, and several articles on English constitutional and legal history.

Anthony S. Wohl, an Assistant Professor of History at Vassar, was born in London and did his undergraduate work at Jesus College, Cambridge, and his Ph.D. at Brown University. He is the author of several articles on housing conditions of the Victorian working classes in London, and has edited a book of readings on housing reform tracts and newspaper editorials, entitled *The Bitter Cry of Outcast London*. He is presently finishing a book on the housing of artisans and laborers in Victorian and Edwardian London.
