Until now, there has not been a systematic arrangement, orderly editing and compilation, or effective indexing of all of Liberia's statutory enactments. This Code systematizes and brings up to date all the laws enacted in Liberia since 1847, and includes some laws from the country's earlier colonial period.

The first three volumes contain the Constitution, followed by statutes in 37 titles, the latter annotated to show prior legislation, cross references, and repealers. Volume IV contains the Index.
