This is the second of two volumes reporting the results of work undertaken by a group of Oxford sociologists in preparation for a national survey of occupational change in England and Wales. Methodological issues are again discussed; the scaling of occupational status and the analysis of change patterns of stratification are examples. Many supplementary findings are also reported, derived from a reanalysis of the 1949 survey of social mobility conducted by D. V. Glass. The emphasis is on the effects of family and schooling on people's job-chances; how big these effects are, how they are produced, and how we can measure changes in them. Paper covers £1.65

The Social Grading of Occupations

A New Approach and Scale

John H. Goldthorpe and Keith Hope

The authors have produced a coherent system for grouping occupations, based on procedures used in the British Census, but more discriminating than the officially defined categories. They have obtained popular assessments of the social standing of several hundred occupations and, by a novel application of sampling procedures, constructed a scale upon which the position of any employed male can be determined with a known degree of precision. The new classification and the Hope-Goldthorpe scale have been developed as part of the work of the Oxford occupational mobility inquiry, and will promote comparability among social, epidemiological, and other inquiries which involve the collection of information about jobs. A New Series from Yale

Two copies of each contribution, preferably accompanied by a stamped, addressed envelope, should be submitted. Both text and footnotes should be clearly typed with double spacing and wide margins; footnotes should appear on separate pages at the end of the article. Illustrations may be included by arrangement with the editors.

Contributors will receive 50 offprints bound in the journal covers. Any additional offprints must be ordered on receipt of the first proof.
