This view of the status of a wife in all essentials was to persist in the eye of the law for another two and a half centuries from Shakespeare's day.

The Matrimonial Causes Act, 1857, marked the start of a century of change in English family law greater than had taken place in the previous five hundred years. It set in motion a train of events which has far from exhausted its force, as may clearly be seen in the pages of the recently published Report of the Royal Commission on Marriage and Divorce.

The commemoration of this centenary provides the occasion for this work, but is by no means the main or only reason for producing it. There is an interest extending far beyond the legal profession in such problems as the stability of marriage and the increase in divorce, in the right of a deserted wife to continue to occupy the matrimonial home, and in the position of children of broken marriages. This book will assist the general reader to understand the legal background of such problems as these.

The book is a co-operative effort of the staff of the Faculty of Laws of King's College, London. Each contributor has written on a subject within his special sphere of interest and, within the general theme of the book, each has approached his topic in his own way.

The Copyright Act of 1956 enacts a new body of copyright law for the United Kingdom and Northern Ireland. For the first time copyright protection is given to sound recordings, films and broadcasts, as well as to the character and appearance of published editions of literary, dramatic and musical works. The new Act is therefore of immense importance. It supersedes entirely the Act of 1911, discarding its very language and substituting entirely new provisions. It establishes a Performing Right Tribunal for the settlement of disputes over the public performance of copyright works. Particularly important are the transitional provisions of the new Act on account of their retrospective effect.
