THE CONTRIBUTORS

Gordon A. Craig, Professor of History at Princeton University, has written extensively on military and diplomatic subjects. He is currently engaged on a political history of the Prussian army from 1640 to 1945 and, in collaboration with Felix Gilbert of Bryn Mawr College, on a symposium volume to be entitled *Diplomats and Diplomacy in the Interwar Period*.

Nathan Leites is a member of the staff of The Rand Corporation, Visiting Lecturer at Yale University, and Guest Lecturer at the School of Applied Psychoanalysis, The New York Psychoanalytic Institute. He published *The Operational Code of the Politburo* in 1951, and has contributed several articles on Stalinism to *World Politics*.

Edward L. Katzenbach, Jr., having received his Ph.D. in history from Princeton University, was recalled to active duty in the U.S. Marine Corps in 1950 and sent overseas to organize the Historical Section of the Fleet Marine Force Pacific. At present Major Katzenbach is attached to the Joint Chiefs of Staff in Washington, D.C.

Roy Macridis is Assistant Professor of Political Science at Northwestern University. He is currently on leave of absence on a Ford Foundation Fellowship for the purpose of studying the Soviet society and ideology.

Frank L. Klingberg is Professor of Government at Southern Illinois University. He prepared a "Historical Study of War Casualties" for the Secretary of War in 1945, and is at present continuing research on the possible "motivation" of the cyclical tendencies in American history.

Shepard B. Clough, Professor of European History at Columbia University, is abroad as Visiting Professor at the Institut des Etudes Politiques, University of Paris, and at the Faculté de Droit, University of Grenoble. His most recent publication, *The Rise and Fall of Civilization* (1951), is reviewed in this issue of *World Politics*.

Gerhart Niemeyer is a member of the UN Planning Staff in the Bureau of United Nations Affairs, Department of State. Among his publications are *Law Without Force* (1941), *The Second Chance* (edited by John B. Whitton, 1944), and "A Re-appraisal of the Doctrine of Free Speech," *Thought* (1950).

C. E. Black, Associate Professor of History at Princeton University served with the Department of State in Washington and in Eastern Europe from 1943 to 1947. He is co-author with E. C. Helmreich of *Twentieth Century Europe: A History* (1950), and contributed chapter to *Handbook of Slavic Studies* (1949) and *Negotiating with the Russian* (1951).
