## Contributors

**Gina Bombola** earned her PhD in musicology from the University of North Carolina at Chapel Hill. She received the Alvin H. Johnson AMS 50 Dissertation Fellowship for her final year of doctoral study. Her primary area of research focuses on Hollywood's production and marketing of films featuring operatic singers, investigating how these films intersect with representations of gender, race, and class as well as broader cultural phenomena such as the music appreciation movement.

**Daniel Bishop** is an adjunct instructor at Indiana University, where he teaches in the music and general studies program as well as in the musicology department. His dissertation (completed May 2016) was titled "Sounding the Past in the New Hollywood Cinema." His research interests have focused on music and sound in cinema.

He is author of *Music and the Elusive Revolution: Cultural Politics and Political Culture in France, 1968–1981* (University of California Press, 2011). Current projects include a forthcoming book on streaming music and *The Oxford Handbook of Protest Music*, co-edited with Noriko Manabe.

**Jessica Getman** is the managing editor for *The George and Ira Gershwin Critical Edition* at the University of Michigan, Ann Arbor, as well as a film musicologist focusing on music in television and science fiction media. She holds two masters degrees from Boston University in Historical Performance and Musicology, and a PhD from the University of Michigan, for which she produced a dissertation on music and social discourse in the original series of *Star Trek*.

**Julie Hubbert** is an associate professor of music history at the University of South Carolina where she teaches in the school of music and in the film and media studies program. In addition to her book *Celluloid Symphonies: Texts and Contexts in Film Music History* (University of California Press, 2011), she has written numerous articles on a variety of film music topics.

**John Kapusta** is assistant professor of musicology (teaching) at the Eastman School of Music. His research focuses on music and cultural hybridity in the postwar United States. He is currently writing a book on U.S. music and self-actualization culture during the Cold War.

**Tyler Kinnear** completed his PhD in musicology at the University of British Columbia in 2017, with a dissertation that examines conceptions of nature in contemporary Western art music. His teaching and research interests include ecomusicology, sound ethnography, and histories and theories of listening. Kinnear has contributed to the *Ecomusicology Review*, *Music & Politics*, *Organised Sound*, and *Soundscape: The Journal of Acoustic Ecology*.

**Jim Lovensheimer** is associate professor of musicology at Vanderbilt University's Blair School of Music. He attended the University of Cincinnati College-Conservatory of Music, the University of Tennessee-Knoxville, and Ohio State University, from which he received his PhD. The recipient of several teaching and service awards at Vanderbilt, Jim is the author of *South Pacific: Paradise Rewritten* (Oxford University Press, 2010). He is currently at work on a critical assessment of librettist-lyricist Oscar Hammerstein II, also for Oxford.

**Amanda Modell** is a PhD candidate in cultural studies at the University of California, Davis. Her dissertation research considers several convergences between music and the hereditary sciences, including Pandora's Music Genome Project, eugenic studies of human musical ability, and the evolution of whale song. She's grateful for support from the American Philosophical Society, the UC Davis Humanities Institute, the UC Davis Feminist Research Institute, and the UC Davis Social Justice Initiative. Her work has also been featured in *Media Fields*.

**Samuel Parler** is a visiting assistant professor of musicology at Denison University. He received his PhD in historical musicology from Harvard University in 2017 with the support of a Mellon/ACLS Dissertation Completion Fellowship. His current research examines the tension between multiracial performance history and discourses of whiteness and nationalism in commercial country music from the 1920s through the 1940s.

**Tamar Sella** is a PhD candidate in ethnomusicology at Harvard University, working in both Israel and the United States. In Israel, she works on music and Mizrahiyut, and her dissertation is on the social politics of contemporary popular Yemeni-Jewish music and its unheard archives. In the United States, she works on vocal aesthetics and identity politics in jazz and creative improvised music, and is a founding member of We Have Voice, a collective promoting gender equity in the performing arts.

**John D. Spilker** is associate professor of music at Nebraska Wesleyan University. His research on Henry Cowell's contribution to the development and dissemination of dissonant counterpoint is published in the *Journal of the Society for American Music* and *American Music*. His pedagogy research explores new approaches to music history course design, teaching writing, diversity and inclusion, assessment, and student-centered learning processes. He has presented research at the American Musicological Society, the Society for American Music, and the Society for Music Theory.

**Patrick Warfield** is an associate professor of musicology at the University of Maryland where he also serves as associate director of the school of music. Most of his work focuses on musical life in late nineteenth-century Washington, D.C. He is the author of a biography of John Philip Sousa, entitled *Making the March King*, published by the University of Illinois Press.
