✎ With the beginning of Volume V (1972) Werner T. Angress, Otto P. Pflanze, and Carl E. Schorske have joined the Board of Editors of *Central European History*. They replace Gordon A. Craig, Oron J. Hale, and Enno E. Krache, all of whom have served since the foundation of the journal.

✎ The American, British, French, and German editors of the German Foreign Ministry Documents recently announced publication of Series E, Volume II of the *Akten zur deutschen auswärtigen Politik 1918–1945*, covering the period March through June 1942. This follows publication earlier this year of Series B, Volume V (March through June 1927). It should also be noted that the first volume of the German version of Series C has come out, dealing with the early Nazi period. It is based on the earlier edition in English of that Series.

The editors of the German Documents Project also would like to call attention to the fact that editions of all volumes of their publication, past and future, are limited. Early orders, especially from research libraries, are thus advisable. It should be noted that a surprising number of American research libraries are not ordering these volumes, while others are ordering only some of the Series being published. Interested scholars are therefore urged to check whether their own libraries' holdings are complete.

✎ On April 15, 1972, a "Conference on Ideology and Labor Movements" was held at Madison, Wisconsin, sponsored jointly by the Conference Group for Social and Administrative History, the School for Workers and the History Department of the University of Wisconsin, and the Wisconsin State Historical Society. Among the papers of particular interest to readers of *Central European History* were Kenneth R. Calkins (Kent State University), "The Impact of Orthodox Marxism on the German Social Democratic Movement in the Early Twentieth Century," and Robert F. Wheeler (University of Southern California), "Grass Roots Internationalism in Germany during and after World War I." All of the papers will be printed in the *Transactions* of the Conference Group for Social and Administrative History.
