## CONTRIBUTORS

**Christopher W. Morris** is Professor of Philosophy at Bowling Green State University. He is the author of *An Essay on the Modern State* (1998) and the editor of two recent collections, *The Social Contract Theorists: Critical Essays on Hobbes, Locke, and Rousseau* (1999) and *Rational Commitment and Social Justice: Essays for Gregory Kavka* (1998), the latter coedited with Jules Coleman. His current research is for the most part on moral conventionalism and questions of justice in international affairs.

**Josiah Ober** is the David Magie Professor of Ancient History at Princeton University, where he is Chairman of the Classics Department and holds a joint appointment in the University Center for Human Values. His work centers on the theory and practice of classical Greek democracy and on its relevance for the critical assessment of contemporary political arrangements and social values. He is the author of several books, including *Mass and Elite in Democratic Athens* (1989), *The Athenian Revolution* (1996), and *Political Dissent in Democratic Athens* (1999), all published by Princeton University Press.

**Loren E. Lomasky** is Professor of Philosophy at Bowling Green State University. He previously taught for and chaired the Philosophy Department at the University of Minnesota, Duluth, and has held visiting positions at Virginia Polytechnic Institute, Australian National University, and the Australian Defence Force Academy. He is the author of *Persons, Rights, and the Moral Community* (1987), for which he was awarded the 1990 Matchette Prize for the best philosophy book published during the preceding two years by an author under age forty. His most recent book, coauthored with Geoffrey Brennan, is *Democracy and Decision: The Pure Theory of Electoral Preference* (1993), and he also coedited with Brennan a collection entitled *Politics and Process: New Essays in Democratic Theory* (1989).

**Geoffrey Brennan** is Professor of Economics in the Social and Political Theory Group, Research School of Social Sciences, Australian National University. He is currently completing a book with Alan Hamlin entitled *Democratic Devices and Desires*, to be published by Cambridge University Press. His earlier works include *The Power to Tax* (1980) and *The Reason of Rules* (1985), both coauthored with James Buchanan, and *Democracy and Decision* (1993), coauthored with Loren E. Lomasky.

**N. Scott Arnold** is Professor of Philosophy at the University of Alabama at Birmingham. He is the author of *The Philosophy and Economics of Market Socialism* (1994) and *Marx's Radical Critique of Capitalist Society* (1990). He has been a visiting scholar at the Hoover Institution at Stanford University and at the Social Philosophy and Policy Center at Bowling Green State University.

**Russell Hardin** is Professor of Politics at New York University. He is the author of *Liberalism, Constitutionalism, and Democracy* (1999), *One for All* (1995), *Morality within the Limits of Reason* (1988), and *Collective Action* (1982). He was for many years the editor of *Ethics*. He is currently at work on a book on problems of the rationality and epistemology of ordinary mortals.

**David Estlund** is Associate Professor of Philosophy at Brown University, and has taught previously at the University of California, Irvine. He has received fellowships from the American Council of Learned Societies, the Harvard Program in Ethics and the Professions, and the National Endowment for the Humanities. His publications, mainly on normative issues relating to liberalism and democratic legitimacy, include articles in the *Journal of Philosophy*, *Philosophical Review*, and *Ethics*.

**Amy Gutmann** is Laurance S. Rockefeller University Professor of Politics at Princeton University. She is also the Founding Director of Princeton's University Center for Human Values. Among her books are *Liberal Equality* (1980); *Democratic Education* (1987); *Democracy and Disagreement* (1996), coauthored with Dennis Thompson, which *Choice* named as one of the "outstanding political science books for 1997"; and *Color Conscious: The Political Morality of Race* (1986), coauthored with Anthony Appiah, which won the American Political Science Association's Ralph J. Bunche Award "for the best scholarly work in political science that explores the phenomenon of ethnic and cultural pluralism." She has also edited many books, most recently *Freedom of Association* (1998), and has published many articles in moral and political philosophy, education and multiculturalism, and ethics and public affairs.

**Dennis Thompson** is the Alfred North Whitehead Professor of Political Philosophy at Harvard University, and the Founding Director of Harvard's Program in Ethics and the Professions. In addition to *Democracy and Disagreement* (1996), coauthored with Amy Gutmann, he is the author of *The Democratic Citizen: Social Science and Democratic Theory in the Twentieth Century* (1970), *John Stuart Mill and Representative Government* (1976), *Ethics in Congress: From Individual to Institutional Corruption* (1995), *Political Ethics and Public Office* (1987), and numerous articles on democratic theory and political ethics.

**William Nelson** is Professor of Philosophy and Chair of the Department of Philosophy at the University of Houston. He is the author of *On Justifying Democracy* (1980) and *Morality: What's in It for Me?* (1991), as well as a number of essays in moral, political, and legal philosophy. He is currently working on issues concerning moral and legal rights.

**Kenneth Minogue** is Emeritus Professor of Political Science at the London School of Economics. He was born in New Zealand, was educated in Australia, and is the author of *The Liberal Mind* (1963), *Nationalism* (1967), *The Concept of a University* (1974), *Alien Powers: The Pure Theory of Ideology* (1985), and *Politics: A Very Short Introduction* (1995). He has coedited (with Anthony de Crespigny) *Contemporary Political Philosophers* (1976) and (with Michael Biddis) *Thatcherism: Personality and Politics* (1987). In 1996, he edited *Conservative Realism: New Essays*, and he has also edited and introduced the Everyman edition of Hobbes's *Leviathan*. As Senior Research Fellow at the Social Affairs Unit in London, he wrote *The Silencing of Society: The True Cost of the Lust for News* (1997), and he has written *Waitangi, Morality and Reality* (1998), a study of Maori-Pakeha relations in New Zealand, for the New Zealand Business Roundtable.

**Steven Wall** is Assistant Professor of Philosophy at Kansas State University. He has taught previously at the University of Virginia and at Baruch College, City University of New York. He is the author of *Liberalism, Perfectionism, and Restraint* (1998), and is currently working on a study on the value of democratic political participation.

**William A. Galston** is Professor at the School of Public Affairs, University of Maryland, and Director of the Institute for Philosophy and Public Policy. His publications include *Kant and the Problem of History* (1975), *Justice and the Human Good* (1980), *Liberal Purposes: Goods, Virtues, and Diversity in the Liberal State* (1991), and *Virtue* (coedited with John W. Chapman, 1992). He has also served as Deputy Assistant to President Clinton for Domestic Policy (1993–1995) and Executive Director of the National Commission on Civic Renewal (1996–1998).

**Dmitry Shlapentokh** is Associate Professor of History at Indiana University, South Bend. He was born and educated in the former Soviet Union, and received his Ph.D. in Russian/European history from the University of Chicago.
