**Alexis Álvarez** teaches college-level sociology and statistics courses, and is completing his sociology dissertation at University of California–Riverside. His research interests include globalization, sociolinguistics, and structural inequality in the world system.

**Rebecca Álvarez** is a Postdoctoral Research Associate at the Institute for Research on World-Systems at the University of California–Riverside. She received her PhD in sociology from the University of California–Riverside in 2011 and does research on the evolution of gender inequality.

**E. N. Anderson** is professor of anthropology, Emeritus, at the University of California–Riverside. He received his PhD in anthropology from the University of California, Berkeley, in 1967. He has done research on ethnobiology, cultural ecology, political ecology, and medical anthropology, in several areas, especially Hong Kong, British Columbia, California, and the Yucatan Peninsula of Mexico. His books include *The Food of China* (1988), *Ecologies of the Heart* (1996), *Political Ecology of a Yucatec Maya Community* (2005), and *The Pursuit of Ecotopia* (2010).

**Francisco J. Beltrán Tapia** is a Deakin postdoctoral fellow in economics at Magdalene College, University of Cambridge. His main interest is the analysis of how societies build institutions that promote or limit economic development, the conditions under which these institutions evolve, and their influence on economic development. His PhD thesis, defended at University of Oxford, analyzed the enclosing of the commons in nineteenth- and early-twentieth-century Spain and its impact on different economic and social dimensions.

**Christopher Chase-Dunn** is Distinguished Professor of Sociology and Director of the Institute for Research on World-Systems at the University of California–Riverside. He received his PhD in sociology from Stanford University in 1975. Chase-Dunn has done cross-national quantitative studies of the effects of dependence on foreign investment, and he studies cities, empires, and settlement systems in order to explain human sociocultural evolution. His research focuses on interpolity systems, including both the modern global political economy and earlier regional world systems.

**Jordi Domenech** is an associate professor at the Department of Social Sciences at Universidad Carlos III de Madrid (Spain). Previously he was a lecturer in economic history at the London School of Economics and at the University of York. Articles of his have appeared in the *Economic History Review*, *Explorations in Economic History*, *Journal of International Development*, and *Labor History*. His recent research analyzes the causes of the collapse of democracy in 1930s Spain.

**Emily Erikson** is an assistant professor of sociology at Yale University School of Management. Her work focuses on the development and emergence of the institutions

of capitalism as well as network theory, with a particular emphasis on the role of social networks, decoupling, and autonomy in institutional generation and transformation. She recently authored *Between Monopoly and Free Trade: The English East India Company, 1600–1757* (2014) and edited “Chartering Capitalism: Organizing Markets, States, and Publics,” a special issue of *Political Power and Social Theory* (2015).

**Hiroko Inoue** is a PhD candidate in the Sociology Department at University of California–Riverside. Her research interests are world-systems analysis, formal and simulation modeling, network analysis of cities and states, and sociological theory. She is serving as a research associate at the Institute for Research on World-Systems at University of California–Riverside and is engaged in research on the evolutionary rise and fall of cities, states, and empires and global state formation.

**Kirk S. Lawrence** is an assistant professor of sociology at St. Joseph’s College, New York. His research interests are in the areas of environmental degradation, ecological sustainability, world-systems analysis, and social evolution. His work has appeared in *Human Ecology Review*, *International Journal of Comparative Sociology*, and *Global Society*.

**Kaat Louckx** is a postdoctoral researcher in the Department of Sociology of Ghent University (Belgium). She has recently completed a PhD dissertation on the politics of membership and belonging, and more particularly, on the étatisation of belonging in the nineteenth and early twentieth century in Belgium. Her research interests include conceptual history, statistical and bureaucratic systems of thought, and social science history. She is preparing a book manuscript on the sociological history of censuses and administrative statistics.

**Richard Maisel** is associate professor at the New York University Department of Sociology, New York University. Previously he was Director of News Research CBS News, Manager of Public Relations Research General Electric Corporation, Chief Statistician at International Research Associates, President of American Association of Public Opinion Research, and Secretary of World Association for Public Opinion Research. He is coauthor of text on sampling procedures, *How Sampling Works* (1995).

**Andrew L. Owen** received his MA in sociology from the University of California–Riverside, where his research focused on the impacts of natural resource dependence on cross-national income inequality. He is currently a PhD student in sociology at Northwestern University. His primary research interests rest in political economy, comparative historical sociology, and quantitative methods.

**Peter Tuckel** is professor at the Department of Sociology, Hunter College, City University of New York. He teaches mainly statistics and mapping courses. His primary research interests center on historical patterns of voting, residential segregation, and infectious diseases. His work has been published in a number of journals including

*Public Opinion Quarterly*, *Social Science Quarterly*, and *Journal of Interdisciplinary History*.



His work has appeared in a variety of journals, including *Belgian Journal of History*, *British Journal of Sociology*, *European Journal of Social Theory*, *Journal for the Theory of Social Behaviour*, *Journal of Classical Sociology*, *Memory Studies*, *Minerva*, *Paedagogica Historica*, *Science in Context*, and *Social Science History*. He is preparing a book manuscript on the history of sociology (to be published by Palgrave MacMillan).



## “Risk and Fortune”

Shelby Cullom Davis Center for Historical Studies

During the academic years 2016/17 and 2017/18, the Shelby Cullom Davis Center for Historical Studies will focus on the topic of “Risk and Fortune.” Notions of risk have been important to human societies for centuries. Soothsaying, insurance, medical prognostication, financial investment, and gambling all contend with—or try to contain—possible losses. Conversely, good fortune has had its talismans and theorists throughout history. How have different cultures tried to tame chance, or comprehend its whims? To what degree have the practices of commerce relied upon, or alternatively reified, risk? Do technological systems generate hazards they are not capable of controlling? This two-year seminar will bring together scholars working on risk and fortune in historical societies around the world in all time periods, on topics including (but not restricted to) economics, science, religion, industry, statistics, and agriculture.

The Center will offer a limited number of research fellowships for one or two semesters, running from September to January and from February to June. Early career scholars must have their doctoral degrees in hand at the time of the application. Fellows are expected to live in Princeton in order to take an active part in the intellectual interchange with other members of the Seminar. Funds are limited, and candidates are, therefore, strongly urged to apply to other grant-giving institutions as well as the Center if they wish to come for a full year.
