CONTRIBUTORS

Roger Atwood completed his MA in History at Georgetown University following a BA in History, magna cum laude, from the University of Massachusetts-Amherst and a degree in public policy at the School of Advanced International Studies, Johns Hopkins University. He is a widely published journalist, critic, and poet. His books include *Stealing History* (Macmillan/St Martin's Press, 2004); *Coming of Age in a Hardscrabble World* (University of Georgia Press, 2019, co-editor), and *Nuestra palabra es fuego* (Editorial Universitaria, forthcoming). Peer-reviewed publications include "Gringo Iracundo: Roque Dalton and His Father" (*Latin American Research Review*, 2011) and "Democratic Dictators: Authoritarian Politics in Peru from Leguía to Fujimori" (*SAIS Review*, 2001). He is a writer and editor at the IFC/World Bank Group in Washington, DC.

Matt D. Childs teaches for the History Department at the University of South Carolina (Columbia). His graduate and undergraduate courses deal with Latin American and Caribbean history, Atlantic History, and comparative histories of colonialism and slavery in shaping the modern world. He is the author of *The 1812 Aponte Rebellion in Cuba and the Struggle against Atlantic Slavery*, which was a finalist for the Frederick Douglass Book Prize and has been translated and published in Cuba. He co-edited, with Toyin Falola, *The Yoruba Diaspora in the Atlantic World* and *The Changing Worlds of Atlantic Africa: Essay in Honor of Robin Law*. Childs served as an associate editor for the six-volume *Encyclopedia of Latin American History and Culture*. With James Sidbury and Jorge Cañizares-Esguerra, he co-edited *The Urban Black Atlantic during the Era of the Slave Trade*. His published articles have appeared in many journals: the *Journal of Latin American Studies*, *The Americas*, *The Historian*, *History Workshop Journal*, *Latin Americanist*, *William and Mary Quarterly*, and *Latin American Research Review*. He has been awarded research grants from the Social Science Research Council, the Ford Foundation, the American Council of Learned Societies, the Fulbright-Hays Program, and other agencies to conduct research in Cuba, Spain, Great Britain, and the United States.

David Geggus, Professor Emeritus, was educated in England and held research positions at the Universities of Oxford and Southampton before joining the University of Florida, where he taught Caribbean and Atlantic World history

from 1983 to 2019. His research, conducted in ten countries, has focused on Saint Domingue and the Haitian Revolution. He has published seven books, including *Slavery, War, and Revolution* (Oxford, 1982) and *Haitian Revolutionary Studies* (Bloomington, 2002), and more than 120 academic articles. He has been awarded fellowships by the French government, the British Academy, Royal Historical Society, John Simon Guggenheim Foundation, National Humanities Center, Woodrow Wilson Center for International Scholars, Social Science Research Council, National Endowment for the Humanities, and the John Carter Brown Library. His most recent book is *The Haitian Revolution: A Documentary History* (Cambridge, 2014).

Karen Racine is Professor of Latin American history at the University of Guelph in Canada. She is the author of *Francisco de Miranda: A Transatlantic Life in the Age of Revolution 1750–1816*, and *James A. Brush's Journal of the Expedition and Military Operations of General Don Francisco Xavier Mina in Mexico, 1816–1817*. She is co-editor of two volumes on the Atlantic World in Rowman & Littlefield's Human Tradition series, and *Strange Pilgrimages: Travel, Exile and National Identity in Latin America*. Her articles have appeared in *English Historical Review*, *The Hispanic American Historical Review*, *The Americas*, *Journal of Caribbean History*, *Historia Paedagogica*, *Journal of Genocide Research*, and in several edited collections, including the most recent one: “Deferred But Not Avoided?: Great Britain and Latin American Independence” in *The Cambridge History of the Age of Atlantic Revolutions*. She is finishing a book-length study of Spanish Americans in London from 1808 to 1832 and a general history of Latin American independence in an Atlantic context.

James H. Sweet is Vilas-Jartz Distinguished Professor of History at the University of Wisconsin. He is the author of *Recreating Africa: Culture, Kinship, and Religion in the African-Portuguese World, 1441–1770* (2003); *Domingos Álvares, African Healing, and the Intellectual History of the Atlantic World* (2011); and *Mutiny on the Black Prince: Slavery, Piracy, and the Limits of Liberty in the Revolutionary Atlantic World* (forthcoming 2024).

John Thornton is Professor of History and African American and Black Diaspora Studies at Boston University. He has published widely; his books include *Africa and Africans in the Making of the Atlantic World* (2nd ed., 1998) and *A Cultural History of the Atlantic World* (2012), winner of the Jeremy Bentley Prize from the World History Association.

Christina Mobley is Lecturer in the History of Radical Ideas in the School of History, Classics, and Archaeology at Newcastle University. She is a historian of Africa, the Caribbean, and Atlantic slavery. Her first book manuscript, “Vodou

History: from the Kongo to the Haitian Revolution,” investigates the transatlantic history of the Kongo men, women, and children who endured slavery in Saint Domingue, helped win the most successful slave revolution in history, and founded the first black republic, Haiti. After receiving a PhD from Duke University in 2015, she was Assistant Professor at the University of Virginia, where she was a founding co-director of the university’s first humanities laboratory, Global South: Concept and Practice. Her research has won support from the Mellon Foundation, the American Council of Learned Societies, the Social Science Research Council, and the US Department of Education (FLAS), among others, and she is the recipient of a Fulbright Fellowship.
